Abstract The survey measures the Kansas City area residents' satisfaction with the kcICON project, their perceptions of MoDOT as a result of the project and what, if anything, would impress them regarding the kcICON project. A professional calling center was contracted to obtain a representative sample of MoDOT's District four to obtain a 95% confidence level with a precision of at least +/- 2.4% for the survey. Potential respondents were contacted through random digit dialing (RDD) from late January through mid-February 2010. A total of 1,606 interviews were completed for the study.

Overview and Methodology

The Missouri Department of Transportation (MoDOT) conducted a survey of Kansas City area residents living in District 4 during January of 2010. The survey was designed to gather input from residents about the kcICON project that is currently being completed by MoDOT. A two page survey was administered by phone to a random sample of residents living in MoDOT District 4. A total of 1,606 residents completed the survey. The results for the random sample of 1,606 households have a 95% level of confidence with a precision of at least +/- 2.4%.

Major Findings

- Eighty-six (86%) percent of the residents surveyed indicated that prior to the survey call they had not heard of the kcICON project. Of the 86% of residents who had not heard of the kcICON project 59% indicated that they were familiar with the construction of the New Paseo Bridge and improvements being made to that section of I-29/35.
- Of those residents familiar with the construction half (48%) were either “very satisfied” or “somewhat satisfied” with the job the Missouri Department of Transportation is doing on the project. Thirteen (13%) percent were dissatisfied and the remaining 40% did not know how well MoDOT was doing on the project. *The sum of the percents do not equal 100 due to rounding.* Those residents who indicated they were satisfied were most satisfied with the timeliness at which the project was being completed, how necessary the project was and its ability to improve traffic in the future, and how well the project was planned. Those residents who indicated that they were dissatisfied were most dissatisfied with the timeliness at which the project was being completed, detours near the construction zone, and the delays due to the construction.

- Seventy-seven (77%) percent of residents surveyed who were familiar with the project either “strongly agreed” or “somewhat agreed” that the kcICON project is a good use of tax payers’ dollars; 6% somewhat disagreed with the statement, 4% strongly disagreed, and 13% did not know or did not have an opinion.
- Sixty-six (66%) percent of residents surveyed who were familiar with the project either “strongly agreed” or “somewhat agreed” that the New Paseo Bridge will become a landmark for the City of Kansas City; 11% somewhat disagreed with the statement, 7% strongly disagreed, and 16% did not know or did not have an opinion.
- Fifty-three (53%) percent of residents surveyed who were familiar with the project either “strongly agreed” or “somewhat agreed” that MoDOT is keeping the public informed about the kcICON project; 17% somewhat disagreed with the statement, 13% strongly disagreed, and 17% did not know or did not have an opinion.
- Forty-six (46%) percent of residents surveyed who were familiar with the project either “strongly agreed” or “somewhat agreed” that the kcICON project has improved their opinion of the Missouri Department of Transportation; 14% somewhat disagreed with the statement, 13% strongly disagreed, and 27% did not know or did not have an opinion.
- Thirty-five (35%) percent of residents surveyed who were familiar with the project either “strongly agreed” or “somewhat agreed” that MoDOT is responsive to issues or questions about the kcICON project; 6% somewhat disagreed with the statement, 4% strongly disagreed, and 54% did not know or did not have an opinion.
- Fifty-eight (58%) percent of residents surveyed either “strongly agreed” or “somewhat agreed” with the statement “MoDOT takes into consideration your needs and views in its transportation decision making;” 20% disagreed with the statement, and 22% did not know or did not have an opinion. Of those residents who disagreed with the statement 16% indicated that advertising might improve efforts to consider needs and views of the public in transportation decision making.

OTHER FINDINGS

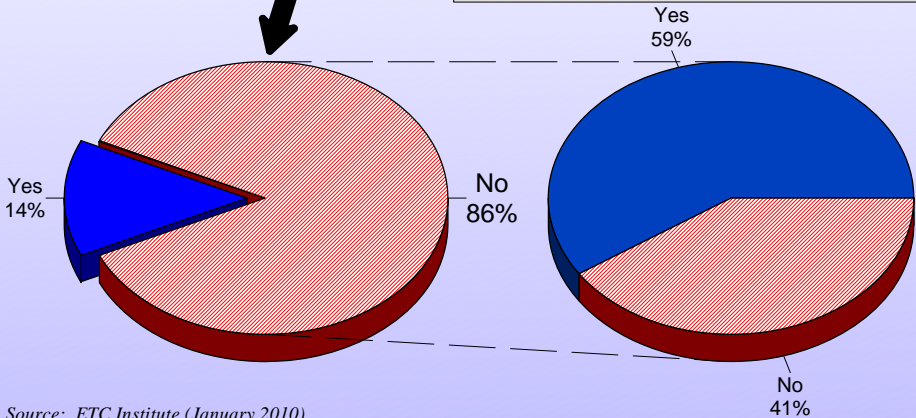
- Fifty-eight percent (58%) of those surveyed indicated that they would most likely go to get information about the kcICON project from the Internet compared to 16% from television, 11% from newspapers, and 5% from the project office.
- When residents who were **satisfied** with the kcICON project were asked why they were satisfied with the project, the most frequently mentioned reason was that the respondent thought the project was being completed in a timely manner. When residents who were **dissatisfied** with the kcICON project were asked to indicate why they were dissatisfied with the project, the most frequently mentioned reason was that the respondent thought the project was taking too long. Different expectations regarding the length of the kcICON project resulted in significant differences in satisfaction. This finding demonstrates the importance of managing customer expectations regarding the length of projects and other issues.

by percentage of respondents

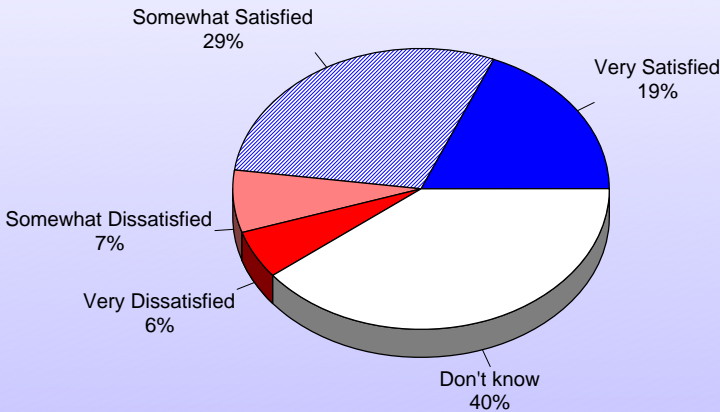

by percentage of respondents



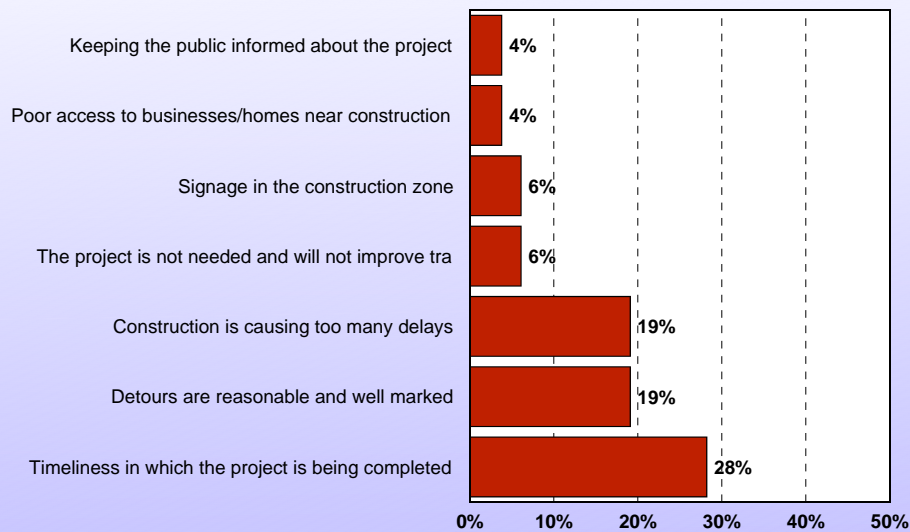

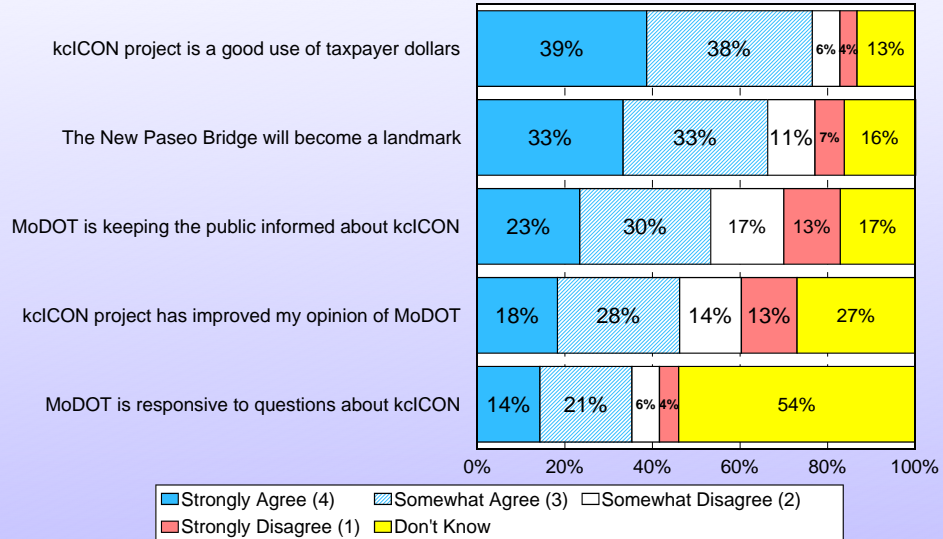
Project Characteristics Residents are Most Dissatisfied With

Level of Agreement with Statements About the kclCON Project and the Missouri Department of Transportation

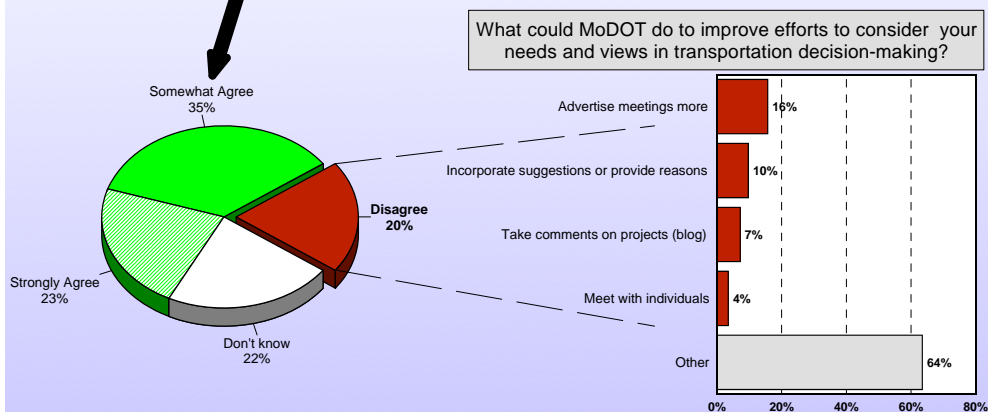
by percentage of respondents who rated the item as a 1 to 4 on a 4-point scale

Agreement with the Statement "MoDOT takes into consideration your needs and views in its transportation decision-making"

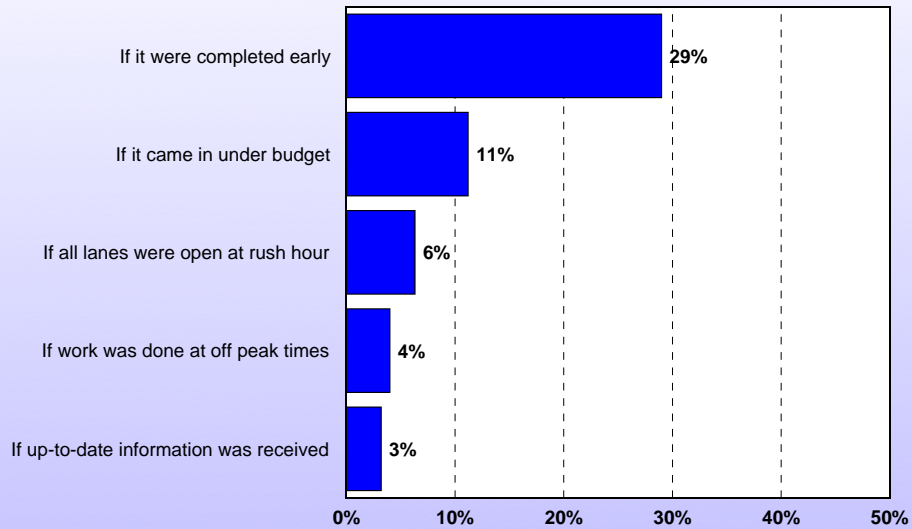
by percentage of respondents

Statements About the kclCON Project that Would Likely Impress Residents

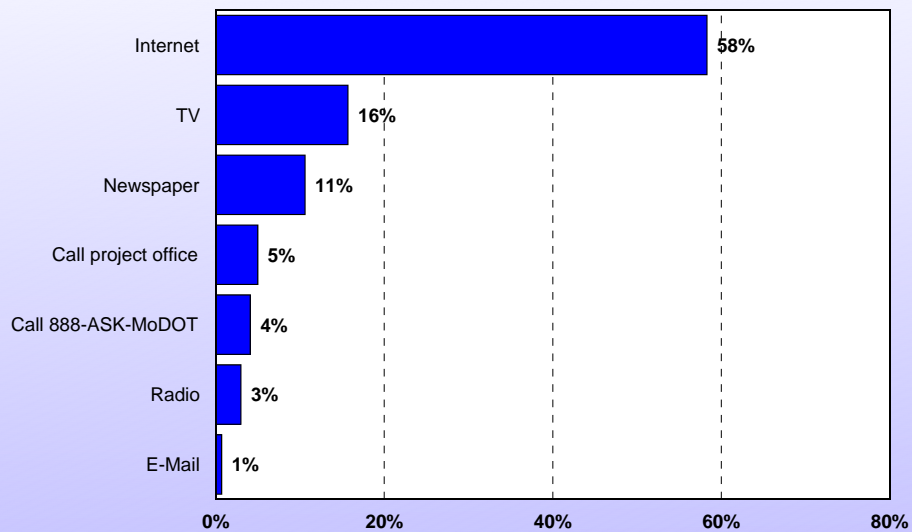
by percentage of respondents (multiple answers possible)

by percentage of respondents (multiple answers possible)



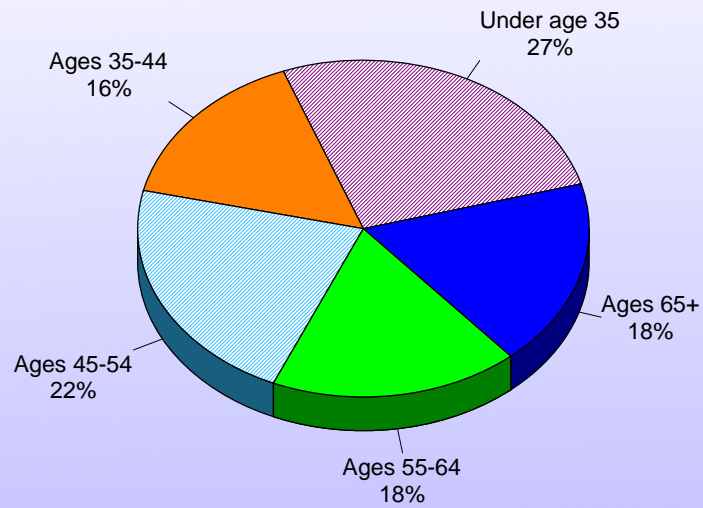

Interpreting the Maps

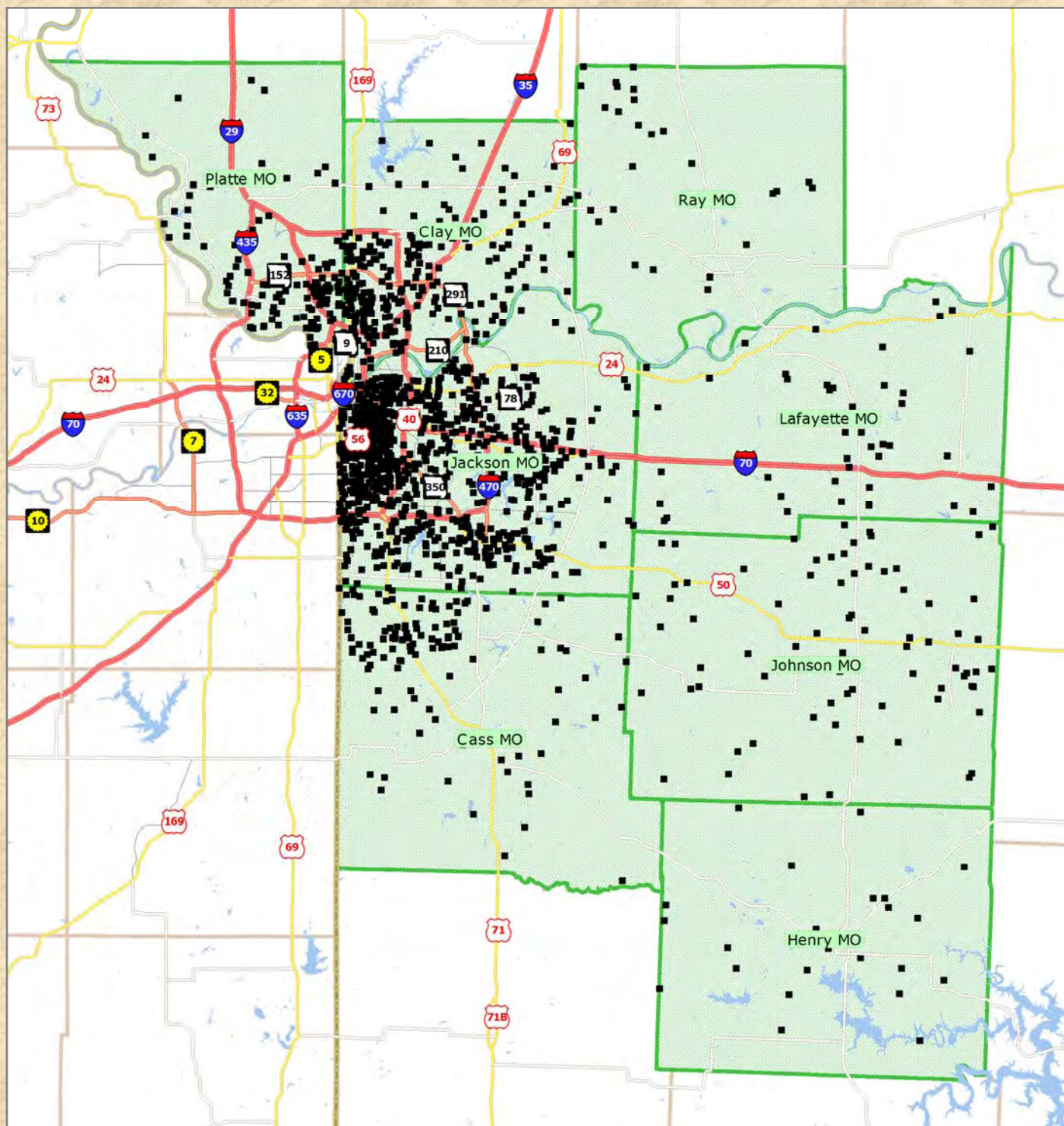
The maps on the following pages show the mean ratings for several questions on the survey by County.

When reading the maps, please use the following color scheme as a guide:

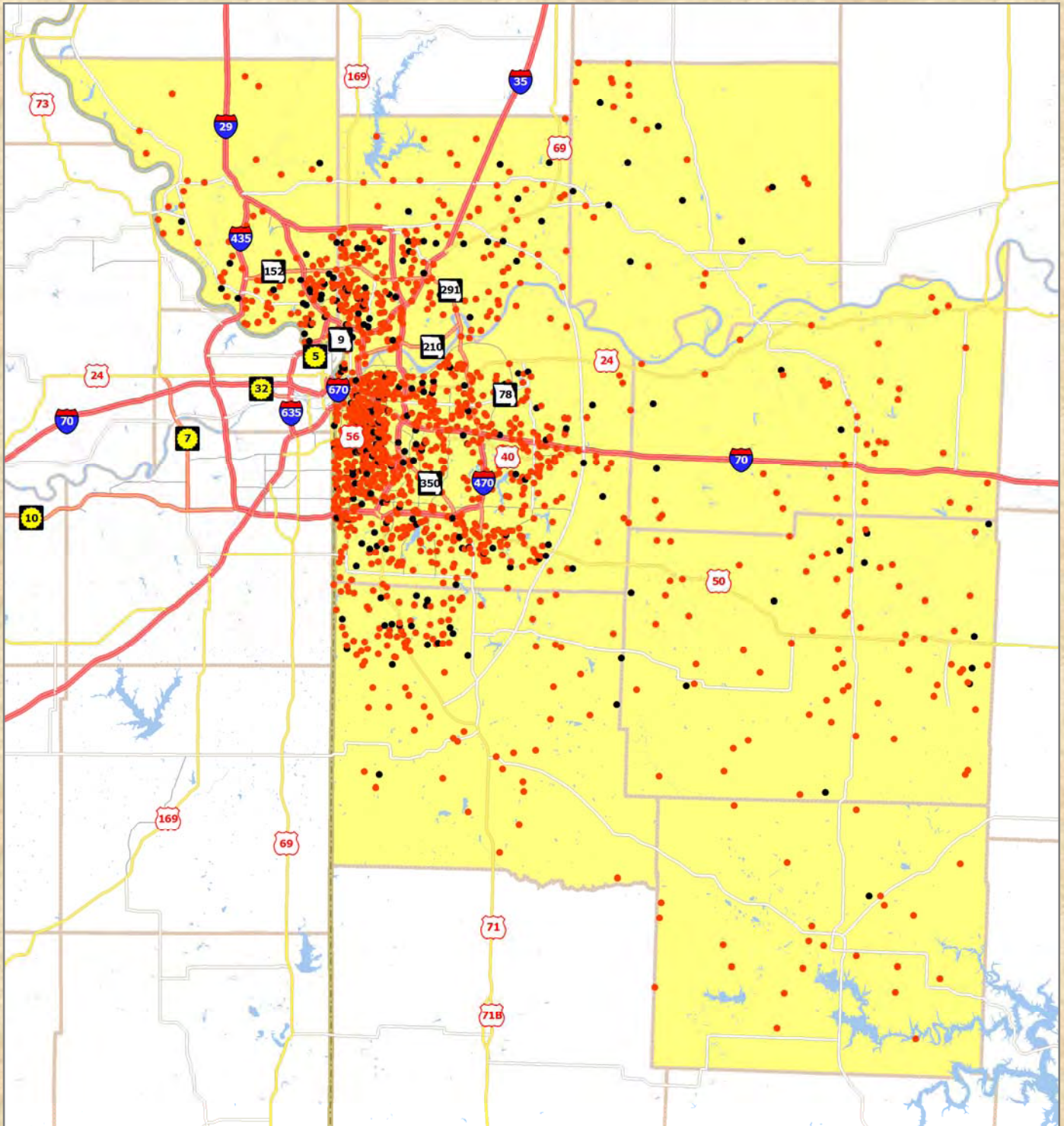
- **DARK/LIGHT BLUE** shades indicate POSITIVE ratings. Shades of blue generally indicate satisfaction/agreement.

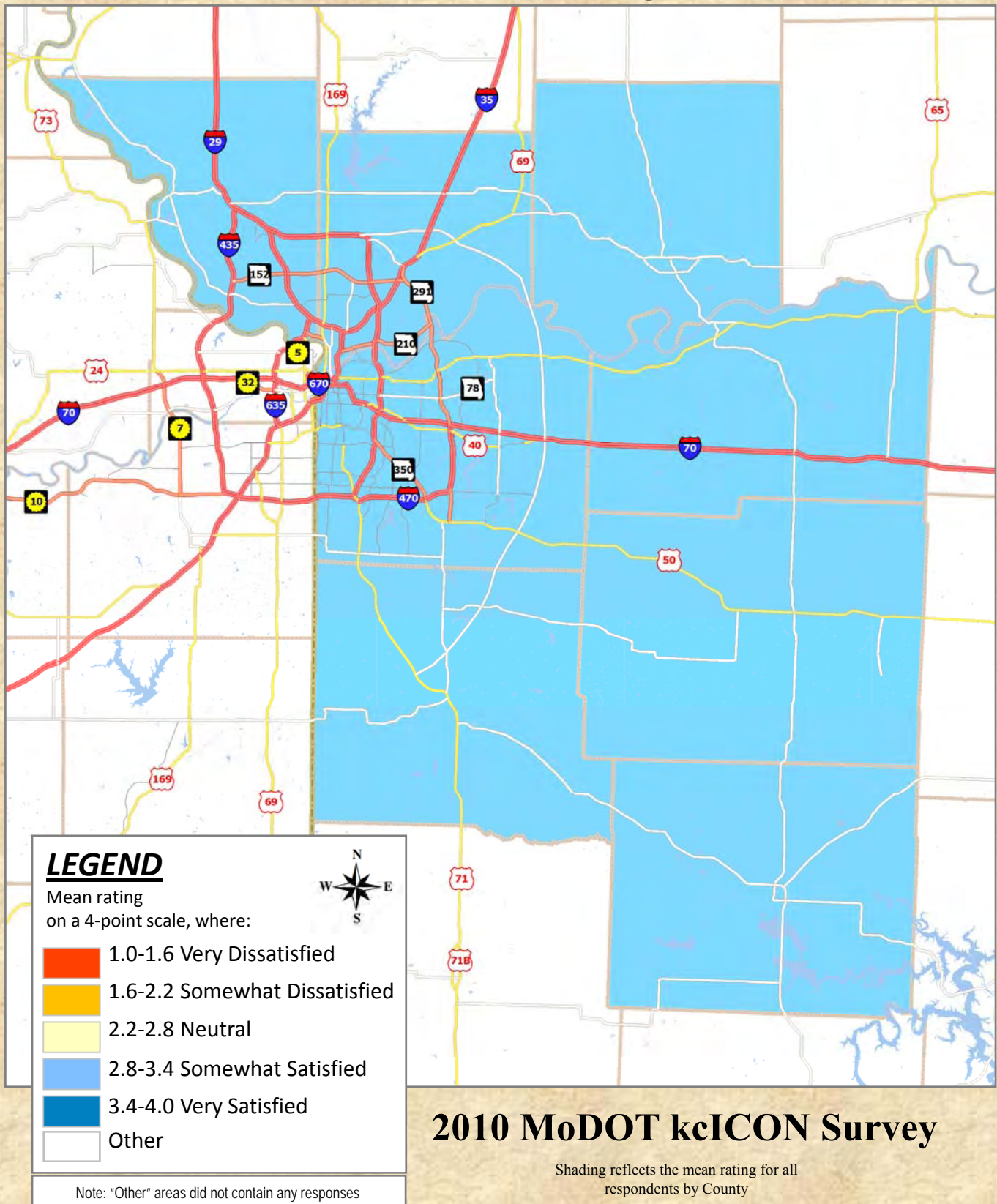

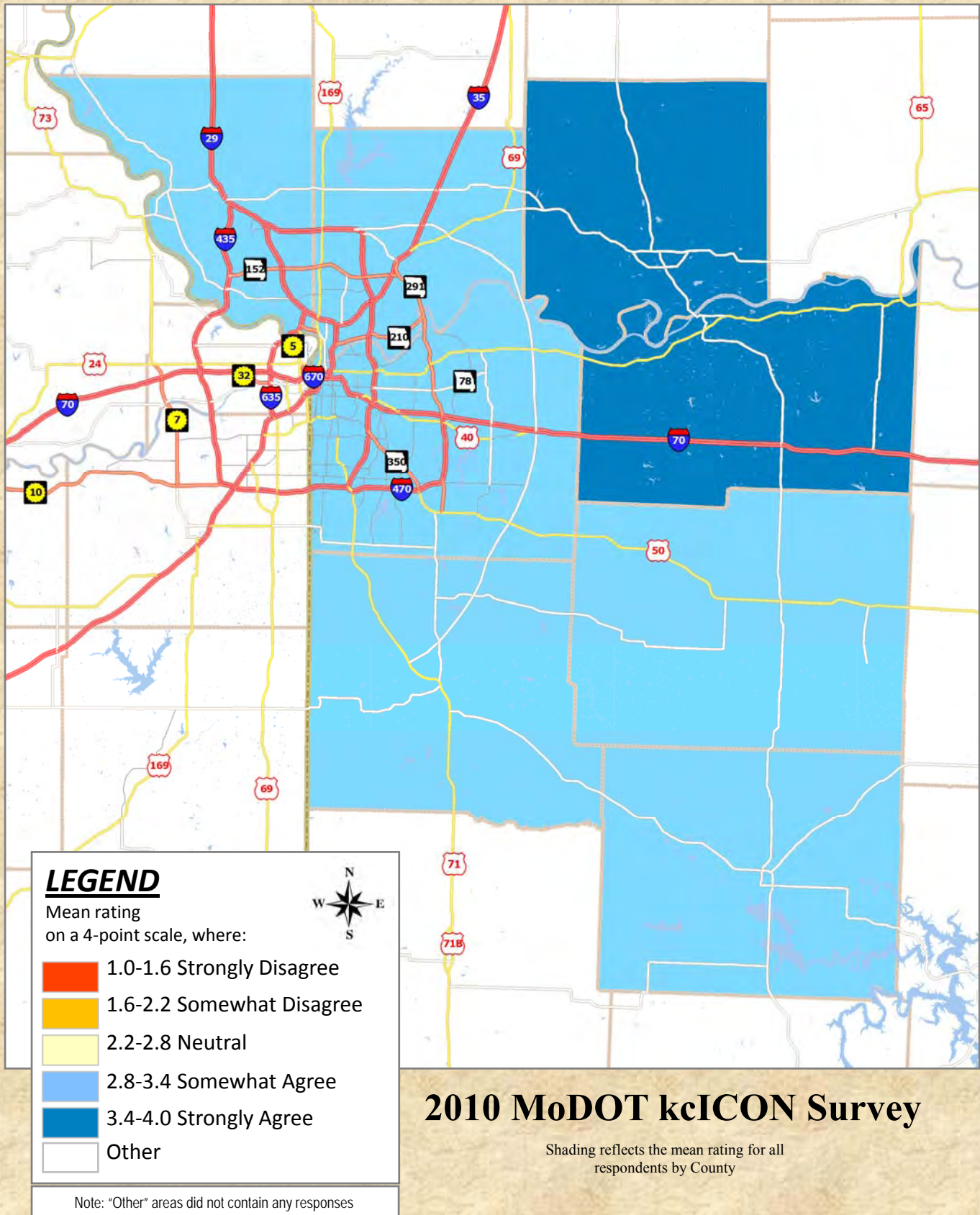

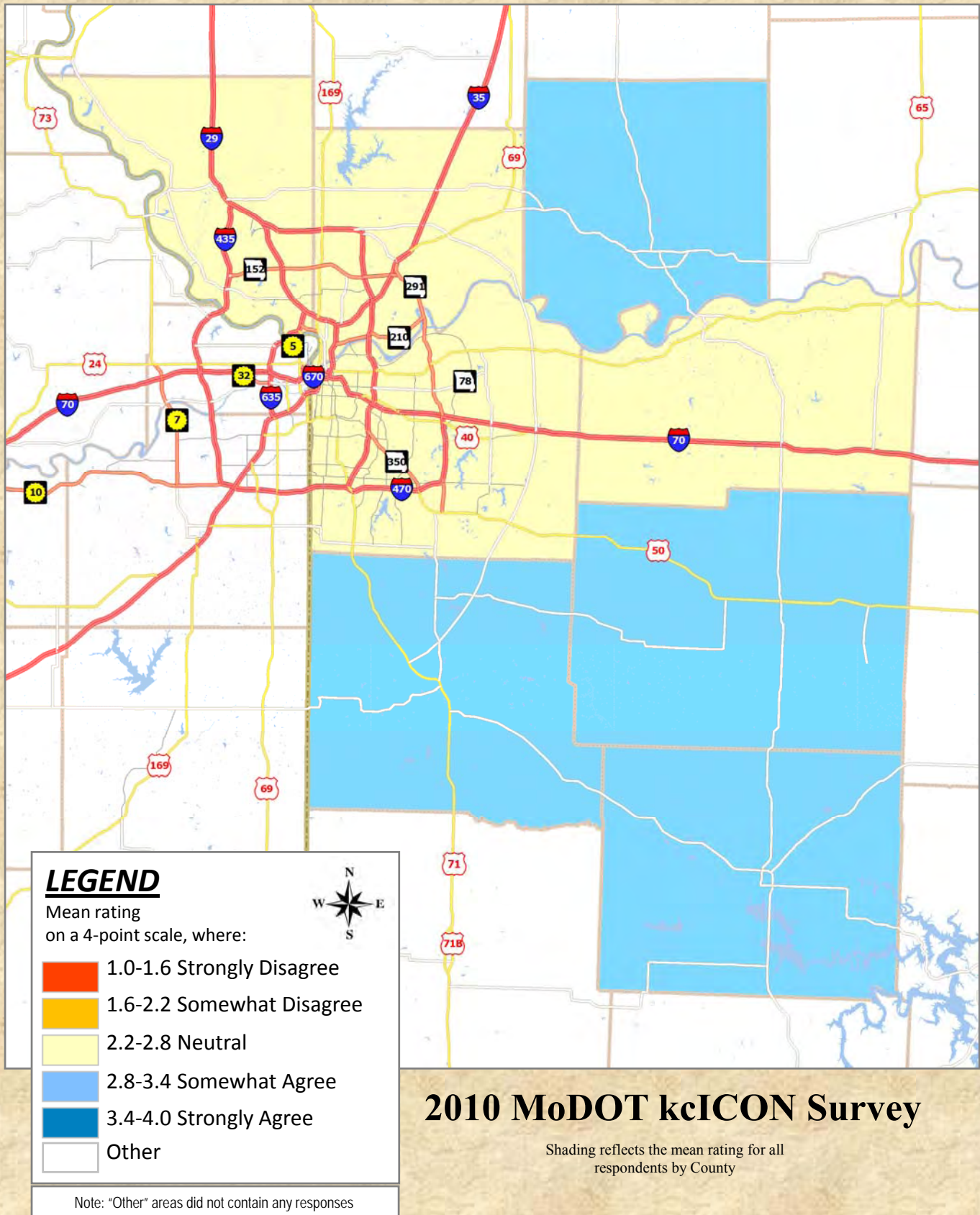

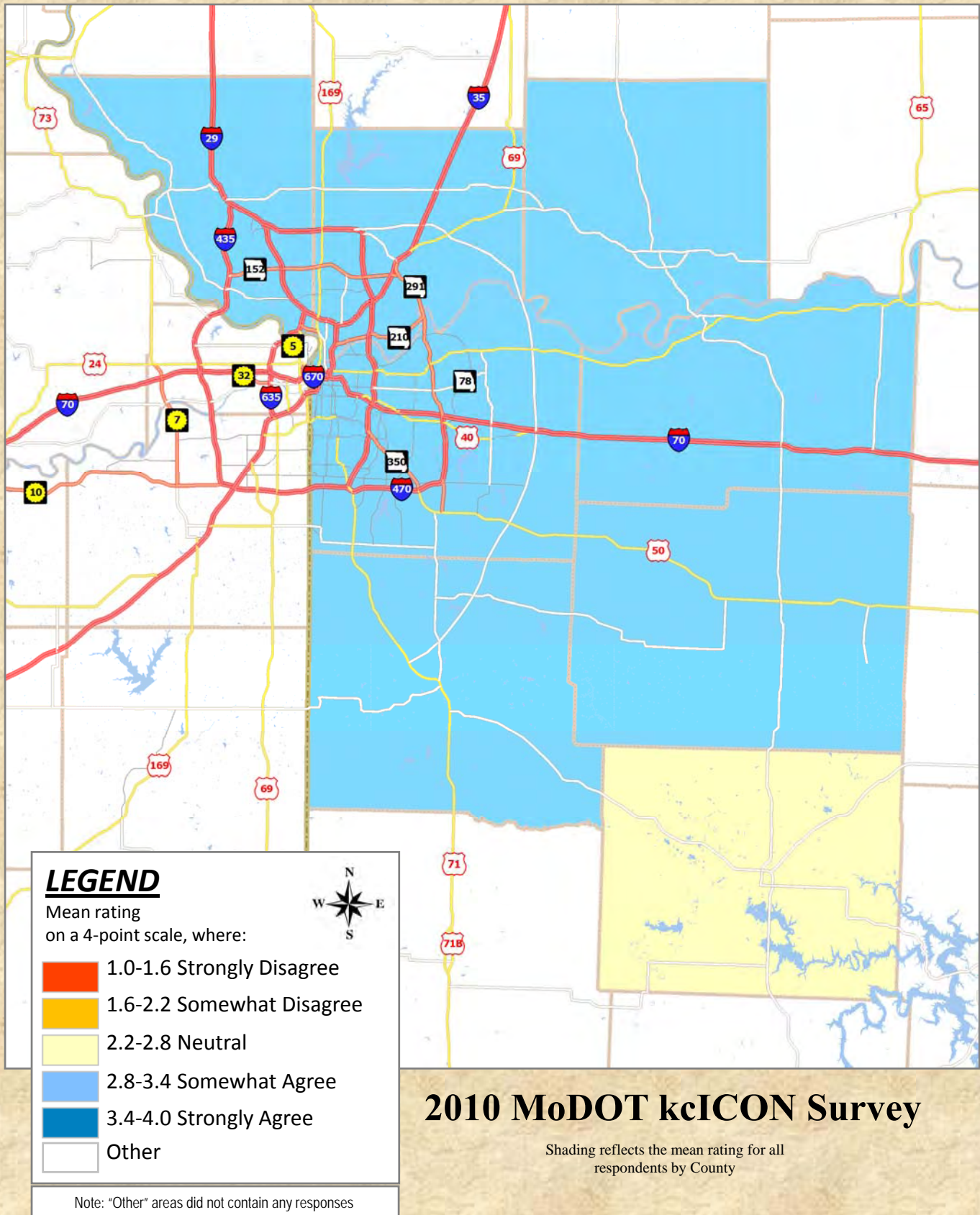
Q3a Level of agreement with the statement “The kcICON project is a good use of taxpayer dollars”



Q3b Level of agreement with the statement “MoDOT is keeping the public informed on the kcICON project”



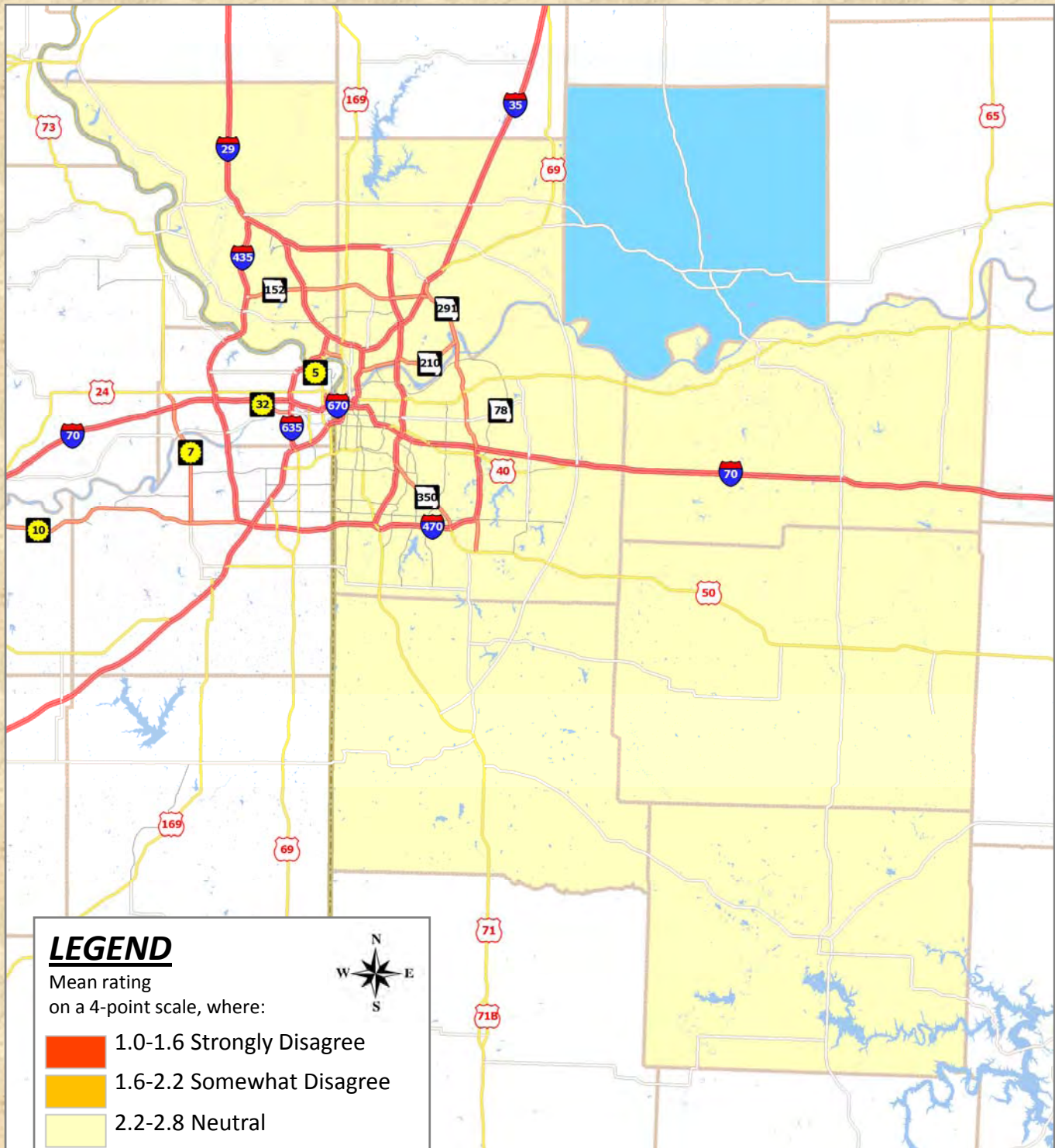
Q3c Level of agreement with the statement “The New Paseo Bridge will become a landmark for the Kansas City area”

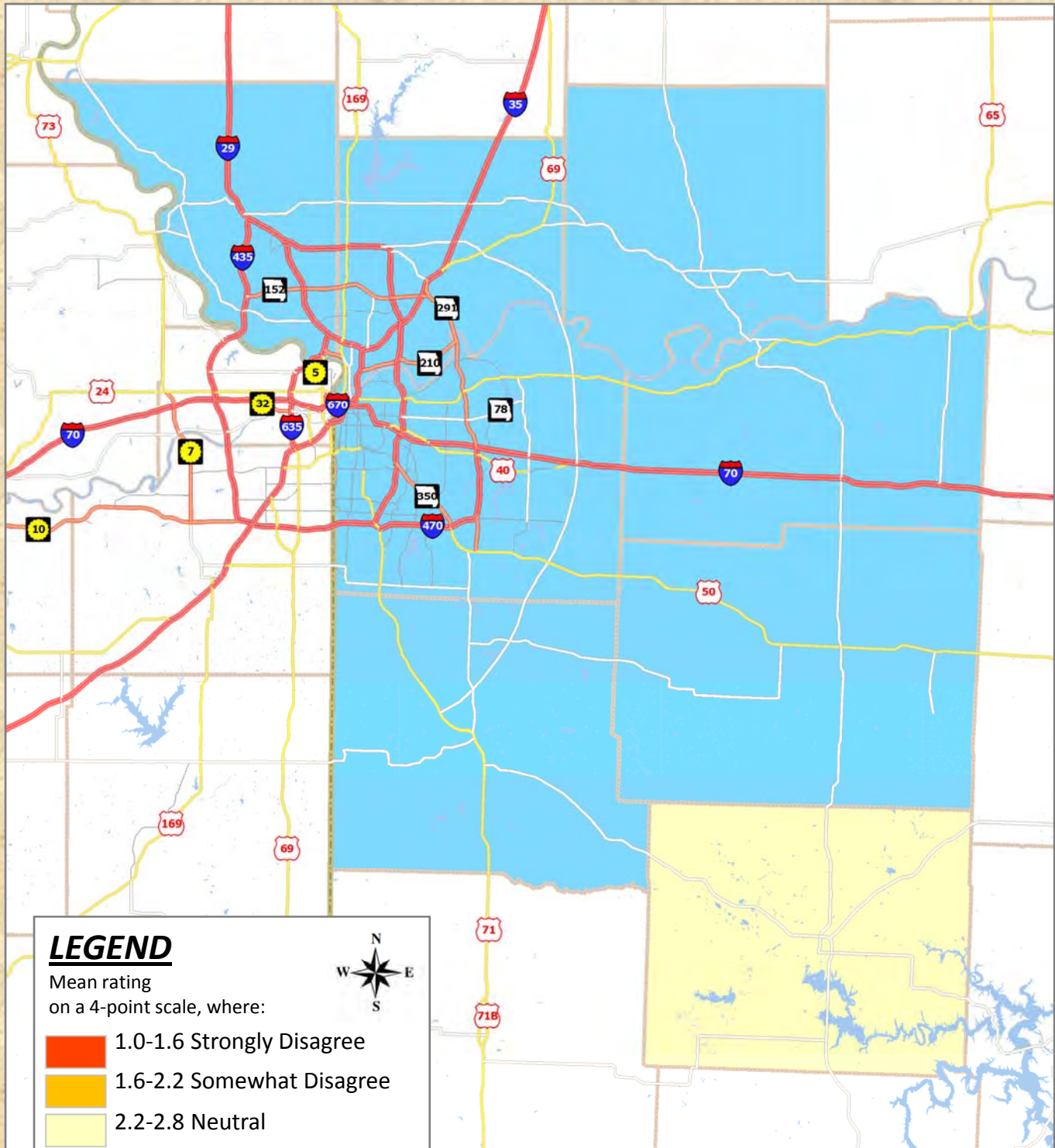
Q3d Level of agreement with the statement “The kcICON project has improved my opinion of MoDOT”

Shading reflects the mean rating for all respondents by County

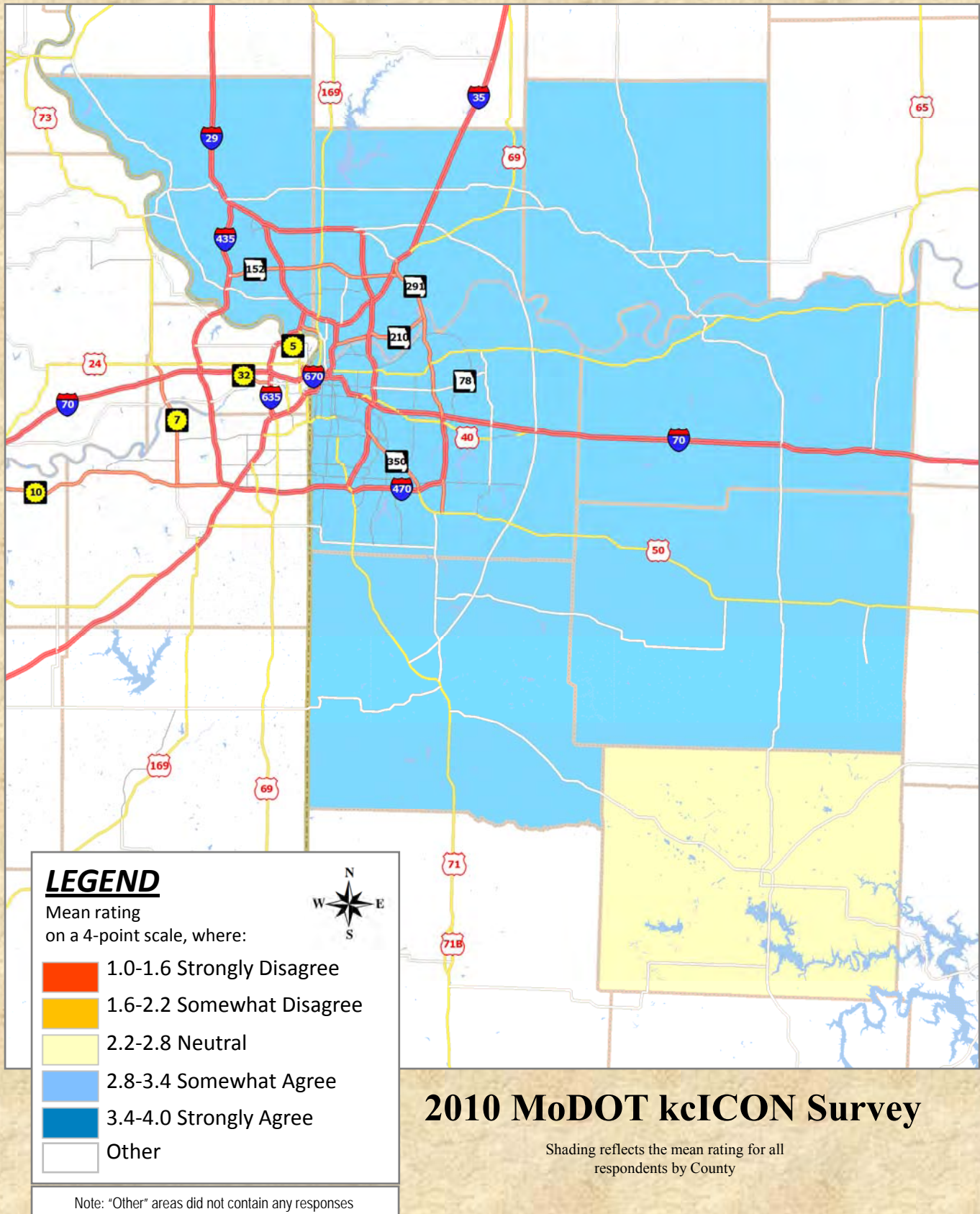
Q3e Level of agreement with the statement “MoDOT has been responsive to the questions and issues I’ve raised regarding the kcICON project”
