

State Infrastructure Bank Annual Financial Report

The Ohio Department of Transportation is pleased to present the Federal Fiscal Year (FFY) 2009 State Infrastructure Bank (SIB) Annual Financial Report.

The portfolio of the FFY 2009 SIB had a total of nine loans totaling \$9.0 million and one bond totaling \$11.7 million. Since the beginning of the program, the Ohio SIB has issued 121 loans and 2 bonds totaling over \$344.7 million.

In addition, the SIB has created two \$5 million dollar reserve funds for each bond fund established (GRF and Federal Title 23). The SIB sold bonds to fund required reserves. All repayments from the existing GRF and Title 23 loan portfolio accounts are pledged to support any borrower repayment shortfall. This pledge is followed by all cash in each respective account, with the reserves being accessed last. The covenants of each program include that these reserves be maintained for any outstanding bonds.

The Federal Title XXIII Transportation Infrastructure Bond Fund was established on July 30, 2008. Similar to the State Transportation Infrastructure Bond Fund (GRF), the bonds are issued on behalf of eligible Ohio political subdivisions. The program received an AA rating from Fitch. This bond program is for projects that are classified as Title XXIII eligible.

This report contains a financial statement of the SIB and loan summaries for loans that closed during the federal fiscal year (October 2008-September 2009). The active project list contains loans that had an open encumbrance or an outstanding balance during the year. Also, there are graphs displayed in the report that reflect the types of loans issued, fund balances and a state map showing the locations of the loans issued.

The Ohio SIB has been audited for State Fiscal Year 2008 by the State of Ohio Auditor's office and complies with the Single Audit Act.

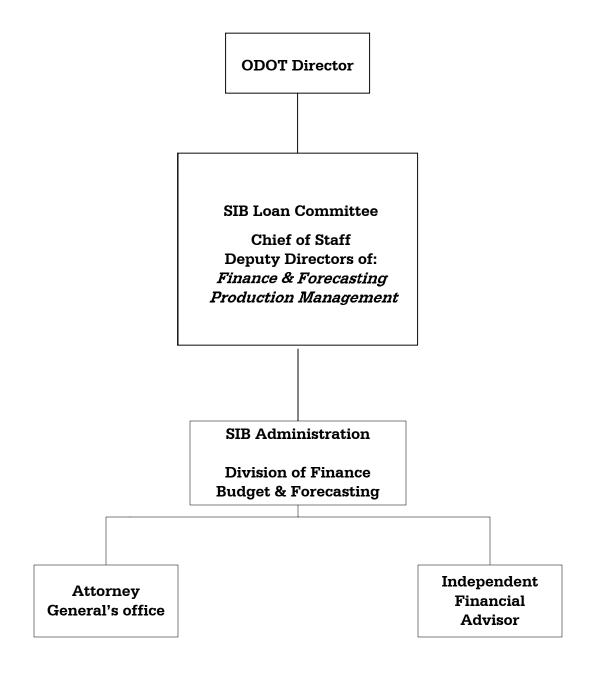

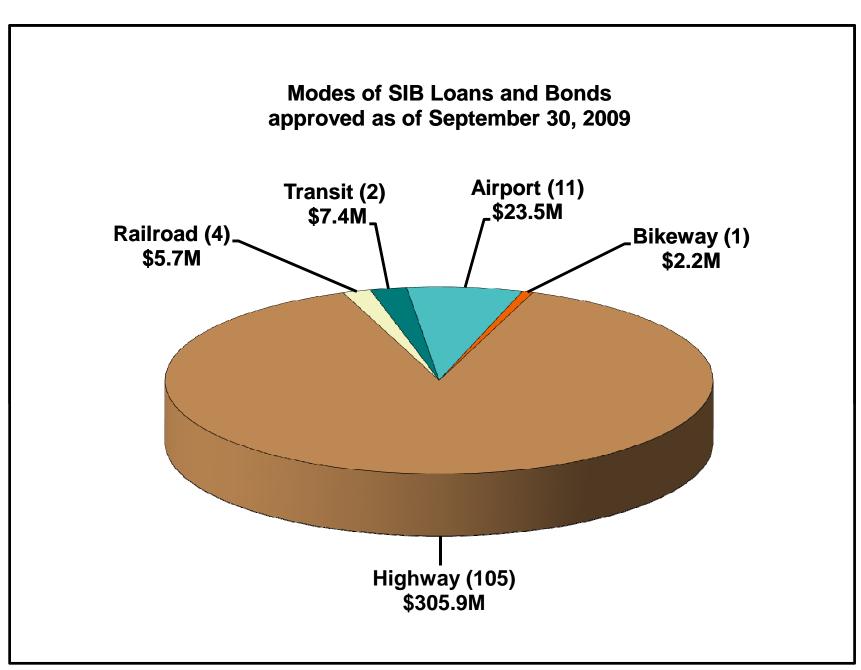

STATE INFRASTRUCTURE BANK (SIB) PROJECTS

A few SIB projects include those found below. They are depicted on the map on the following page.

<u>Toledo Lucas County Port Authority (Lucas County) – Toledo Express Airport Car Rental Facility</u>

The project included the demolition of existing car rental maintenance and fueling facilities, and the construction of a Port Authority owned consolidated car rental facility to service rental cars at the airport. This project reduced the land area currently reserved for rental car service facilities, and freed up needed development space for the airport.

Total Project Costs: \$3,722,000 SIB Loan Amount: \$2,010,000

<u>State Route 682 (Athens County) –</u> The purpose of the project is to widen the existing two-lane State Route 682 to include a third two-way left turn lane. The project also includes the improvement of intersection geometrics; along with waterline work to be performed during the construction of the project.

Total Project Costs: \$5,881,030 SIB Loan Amount: \$171,070

North Water Street – City of Uhrichsville (Tuscarawas County) – The purpose of the project is the rehabilitation of Water Street including planning, resurfacing, drainage improvements, new storm sewers, replacement of traffic signals, reconstruction of curbs and sidewalks, street lights, pavement marking and signage, lying within the City. The total work length of the project is approximately .60 miles. The project improved both pedestrian and vehicular access along the street.

Total Project Costs: \$2,021,890 SIB Loan Amount: \$727,950

<u>USR 22/3 Montgomery Road Project (Hamilton and Warren Counties) –</u> The project involves the widening of US 22/3 (Montgomery Road) from 0.28 miles south of I-275 (at Weller Road) to a point north of Kemper Road. The project includes widening side roads for improved capacity. The total length of the project is 1.72 miles. Both Hamilton and Warren County obtained separate SIB loans to pay for right-of-way acquisition costs for this project.

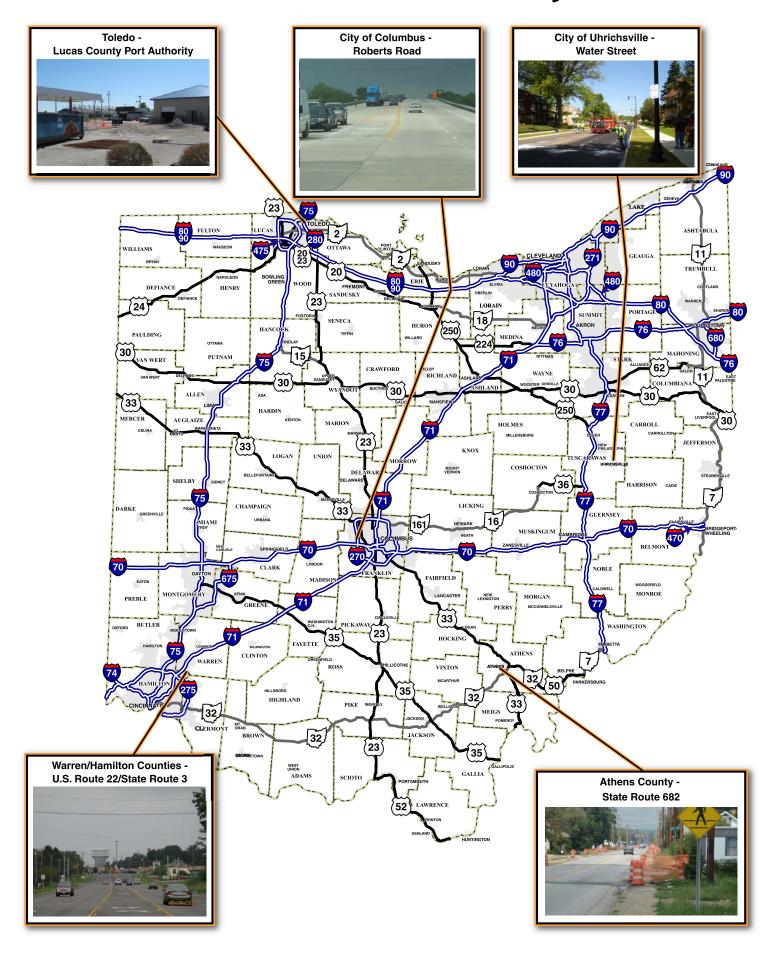

Roberts Road Project - Columbus (Franklin County) — The purpose of the project is to improve capacity and safety for the motoring public. The project entails the major reconstruction of Roberts Road from Hilliard Rome Road to Westbelt Drive. The widening will be from existing two lanes to five lanes with curb, drainage and sidewalks. The length of the project is 1.9 miles.

Total Project Costs: \$10,839,611 SIB Loan Amount: \$7,163,732
