

## I-95 Corridor Coalition PROJECT SUMMARY and CLOSEOUT

**Background:** The Southern Traffic Incident eXchange (STIX) program was implemented on April 1, 2008 to facilitate incident notification/information sharing between the Southern States (Florida, Georgia, North Carolina and South Carolina). The program's intent is to create a seamless incident management program in the region through multi-state coordination.

Developed under Phase I, a manual process was established to collect and disseminate STIX incident information among the region. Enhancements to optimize the manual system were developed under this Phase II project. The project team explored ways to enhance the current system to provide better service to participating stakeholders, and also identified and addressed any issues with the process (miscommunication among stakeholders, misuse or underutilization of the system, coordination with Transcom etc.)

Significant additional outreach activities were needed throughout participating states to further publicize the program benefits as well as to ensure stakeholders fully understand how to use the implementation, for not all stakeholders were using the system to its full potential.

One enhancement that was of particular benefit was the facilitation of a STIX forum to allow various stakeholders—particularly TMC operators and other ground-level TIM personnel—to meet with program representatives and each other face-to-face to debrief incidents, learn more about the program and build relationships with neighboring states. This opportunity for interaction emphasized the importance of STIX and the power of good communication as well as gave stakeholders a more tangible perspective of the program.

**<u>Objective</u>**: To provide additional enhancements to the STIX program while addressing existing issues and expanding stakeholder use by providing additional outreach.

Summary & Accomplishments: For this project, the I-95 Coalition continued coordination of the Southern States with monthly incident review and several outreach sessions among all four states (Florida, Georgia, North Carolina and South Carolina). Of particular note was a severe winter weather incident in North Carolina that resulted in hours of delay for trapped motorist of South Carolina, Georgia and North Carolina; a post-incident debriefing was held under the STIX program. Additionally, there was a hurricane evacuation meeting conducted in Florida to assist all states with a coordinated action plan. The I-95 Coalition has also produced several STIX newsletters to keep members informed of current activities. STIX activations to date (as of the end of this Phase II Project) included:
