U.S. DOT funded through Sept. 30, 2012

The President signed the "minibus" funding legislation on Saturday, Sept. 30, 2011, including three appropriations bills, the Transportation, Housing and Urban Development legislation that provides the Federal Highway Administration (FHWA) funding through the end of this 2012 fiscal year.

Highlights of the Conference Report for H.R. 2112 for FY 2012 are:

- TIGER \$500 million for grants.
- Federal-aid Obligation Limitation \$39,143,582,670, roughly equivalent to new contract authority for the year based on annualization of the extension.
- FHWA Administrative Funds gives the Secretary of Transportation discretion to deduct up to \$16 million from the funds authorized for the 14 discretionary grant programs by the most recent extension act to provide additional funds for FHWA administrative expenses. Limitation on administrative expenses of \$412 million.
- Supplemental Emergency Relief Funds \$1.662 billion from the General Fund for major disasters under the Stafford Act. Waives the \$100 million per-State, per disaster cap for emergency relief projects from damage in FY 2011 from Hurricane Irene or the Missouri River basin flooding in the spring of 2011 (except Devils Lake).
- Requires the Secretary to extend the eligibility for 100 percent Federal share for emergency repairs

beyond the typical 180-day limit in consideration of any delay in the State's ability to access damaged facilities.

- Maine-Vermont Truck Weight Amends 23 U.S.C. 127 (re: Interstate vehicle weight limits) to allow Maine and Vermont to apply State, rather than Federal, laws and regulations concerning Interstate vehicle weight limits through December 31, 2031.
- MUTCD-Limits use of funds under the Act for enforcement of certain MUTCD provisions.
- No Highway Rescissions

TIGER 2011

December 15, 2011, U.S. Transportation Secretary Ray LaHood announced that 46 transportation projects in 33 States, Puerto Rico, and the District of Columbia will receive a total of \$511 million from the third round of the U.S. Department of Transportation's (U.S. DOT) popular TIGER program. The announcement comes months ahead of schedule, and will allow communities to move forward with critical, job-creating infrastructure projects including road and bridge improvements; transit upgrades; freight, port, and rail expansions; and new options for bicyclists and pedestrians.

U.S. DOT received 848 project applications from all 50 States, Puerto Rico, and the District of Columbia, requesting a total of \$14.29 billion, far exceeding the \$511 million made available for grants under this year's TIGER program. Proposed Systems Operations and Management Guidance

AASHTO has posted the final version of the Systems Operations & Management Guidance (SO&M) on the web. The guidance is designed to help transportation agency managers involved with ITS and SO&M at both the State and regional level. It offers customtailored guidance on improving agency capabilities in SO&M based on agency self-evaluation. A "one minute evaluation" version is also available on the site that provides a first cut approach. The guidance, which was funded by U.S. DOT, was based on research prepared for the SHRP 2 and NCHRP programs and has been tested in a number of States and regions. National Congested Corridors Report

The Texas Transportation Institute published the 2011 Congested Corridors Report. It is the first nation-

wide effort to identify reliability problems at specific stretches of highway responsible for significant traffic congestion at different times and different days. It uses data from INRIX, based upon corridors involving freeway segments at least three miles long that are congested at least 10 hours per week. Analysis was done on 328 corridors. These corridors, while accounting for only 6 percent of the Nation's total freeway lane-miles and 10 percent of the traffic, account for 36 percent of the country's urban freeway congestion. Guide on Application of Analysis Tools

The FHWA has posted a new Guide on the Application of Analysis Tools to planning for operations. This document offers recommendations on the management, planning, and conduct of traffic analysis that will promote greater traffic analysis tool consistency

over the typical project development life cycle. The key to managing consistency of traffic analyses throughout the various stages of project development is creating a project delivery analysis plan that describes the project, its purpose, and the objectives of the traffic analysis. It identifies the measures of effectiveness that will be used to evaluate the project and its alternatives, describes the traffic analysis approach (including tools, assumptions, and parameters), identifies risks and contingency plans for dealing with those risks, determines the resource requirements, and lays out the time schedule for the analysis. This guidebook is directed toward professionals operating in State departments of transportation and other agencies responsible for transportation project development and delivery.

NTAQS 2012

The Northern Transportation Air Quality Summit (NTAQS) 2012 will be held in Philadelphia in August 2012. Climate Change Webinar Series

Not Your Parents' Ridesharing/TDM Programs!

Through the tremendous efforts of staff at the U.S. DOT/Volpe Center, the FHWA Office of Planning is developing and will make available reports that describe how today's ridesharing and TDM programs and strategies, many relying on current and evolving technologies, can achieve a multitude of personal and community objectives.

Current ridesharing programs often go far beyond traditional computer matching and now utilize Internet, Instant Messaging, and smart phone applications to make almost instantaneous matches. The report, "Ridesharing Options Analysis and Practitioners' Toolkit" (http://www.planning.dot.gov/documents/RidesharingOptions_Toolkit.pdf), provides case studies from across the country demonstrating how ridesharing can be facilitated both by using simple tools and data as well as sophisticated methods and technologies. The case studies describe how urban, suburban,

and rural communities make available a wide array of rideshare options to provide residents with improved access to jobs and services, while also reducing transportation costs and achieving broader environmental and economic benefits.

As a follow up to that report, additional research is underway to explore how ridesharing and TDM programs can support livable and sustainable communities, including mixed use, walkable and transitoriented neighborhoods and access to affordable housing. Another on-going research effort is identifying MPOs with significant commitments to transportation demand management, including non-motorized transportation, and considering TDM investments as an alternative alongside "traditional" major transportation infrastructure projects. Colorado Energy Smart Transportation Initiative

Beginning in May 2011, a Collaborative Team of Federal and State agencies, MPOs, and rural planning partners in Colorado came together to explore ways to develop "energy smart transportation" strategies.

A work group on planning considered several possibilities, including:

- Policies Adopt a new high-level policy to consider energy in transportation infrastructure planning and spending across all aspects of the Colorado Department of Transportation's (CDOT) work (planning, purchasing, facilities, design, and construction).
- Long-Range Transportation Planning Incor porate consideration of energy efficiency and greenhouse gas emissions (GHG) into the guidance, development, and public outreach for the 2040 Statewide Transportation Plan. Integrate energy efficiency into corridor visions, modal transportation plans, and scenario planning.
- STIP and TIP Development Encourage the planning regions and CDOT to use GHG emissions and energy as a secondary evaluation criterion for project selection and provide tools to measure impacts and make decisions.
- Project Development Incorporate energy considerations into the CDOT Design Manual and construction specifications.

St. Louis Regional Plan for Sustainable Development

A HUD Challenge Grant through Citizens for Modern Transit, a transit advocacy organization in St. Louis, funded the first of three Urban Land Institute (ULI) Technical Assistance Panels (TAP) in the St. Louis region. Project Prioritization and Performance-based Planning Efforts in Rural and Small Metropolitan Regions

The National Association of Development Organizations has released a report that provides an overview of the state of the practice in non-metro regional transportation planning, including the rural planning organizations' common organizational and leadership structures, work elements completed through planning contracts, funding and staffing levels, and decision-making processes. and committee structures. Virginia Rural Planning

The Virginia Department of Transportation (VDOT) is nearing completion of a new four-year initiative for their Rural Transportation Planning Program. VDOT partnered with the Virginia's Planning District Commissions and the local governments to develop Rural Long Range Plans (RLRP) for each of the 20 regions. VDOT worked with each region to evaluate the transportation system in the rural areas to recommend a range of transportation improvements that could best satisfy existing and future transportation needs. These regional plans identify needs based upon the goals and objectives established by the region as well as incorporating further consideration of environmental issues and local desires.

This initiative was aimed at creating regional transportation plans in rural areas that compliment those in the metropolitan areas of the State. The development and components of each RLRP was modeled after the federally mandated metropolitan transportation planning process (continuing, comprehensive, and cooperative). The transportation plans have a minimum planning horizon of 20 years, and address expected impacts of population and employment growth on the transportation system. Each RLRP was developed as a vision plan and will be reviewed every five years. The development of the transportation plans was broken into four general phases: Goals and Data Collection, Analysis and Problem Identification, Public Outreach and Recommendation Development, and Public Endorsement and Regional Adoption.

It is VDOT's goal that each region will be able to use these plans to identify regional priorities for transportation funding and to better quantify the statewide magnitude of needs. Mass DOT Rail PPP

The Commonwealth of Massachusetts and CSX have entered into an agreement that has transferred ownership of South Coast Rail Lines from CSX to Mass DOT, in support of a planned transit project, known

as the South Coast Rail Project. This agreement also transferred ownership of the Boston Terminal Running Track, the West First Street Yard, and the Grand Junction secondary line, to Mass DOT. In September 2012, Mass DOT will also receive property rights along the Boston Main Line, between Framingham and Worcester. This action will also result in at least 20 additional commuter trains running to and from the city of Worcester, in addition to the five Massachusetts Bay Transportation Authority commuter trains that have already begun traveling between Framingham and Boston, over CSX's Boston line.

This public private partnership will result in full double-stack access to Massachusetts by improving the clearance of 31 bridges, thus benefiting businesses and consumers by increasing efficiencies and reducing costs in the movement of goods throughout the region. CSX will be making an investment of more than \$100 million in intermodal facilities in Worcester, West Springfield, and Westborough, as it relocates its facilities from the Beacon Park Yards in Boston. Fourteen Days in Qatar

Last April, Robin Smith and five other FHWA employees traveled half way around the world to conduct a "fact finding" assignment in Qatar. The Government of Qatar requested a team of FHWA staff to visit Qatar as a follow up to meetings a delegation from Qatar had with U.S. DOT officials in January 2011. As the host for the 2022 World Cup and for other, longer term national goals, Qatar has undertaken a massive public works investment/construction program and has sought assistance from the U.S. DOT and FHWA.

The two week trip consisted of interviews with a large number of Qatari officials, government employees and consultants, and engineering contractors about how Qatar conducts its business, plans for, designs, and builds roads and highways. In addition, they learned much about the country's plans to prepare for the World Cup and how it will use that opportunity to improve and expand its transportation system, including the new international airport, its major seaport, and a system of heavy rail subways, light rail routes, people movers, and water taxis or ferry boats.

The final FHWA report has several recommendations to assist Qatar prepare for the World Cup and to achieve its goals to improve the transportation infrastructure for several decades to come. Robin found Doha, Qatar (the major city) to be a fascinating place. It's an intriguing mixture of Western and Middle Eastern cultures.
