PART 71-DESIGNATION OF FEDERAL AIRWAYS,
CONTROLLED AIRSPACE, AND REPORTING POINTS (NEW)

Alteration of Control Zone
and Designation of Transition Area

On April 4, 1963, a Notice of Proposed Rule Making was published in the Federal Register (28 F. R. 3283) stating that the Federal Aviation Agency (FAA) proposed to alter the Santa Fe, N. Mex., control zone and designate the Santa Fe transition area.

Interested persons have been afforded an opportunity to participate in the making of the rules herein adopted, and no adverse comments were received regarding the proposed amendments, including an alternate proposal for multiple extensions in the 700-foot portion of the Santa Fe transition area. Preference for a radius area, to eliminate these extensions, was expressed in the comment received. The FAA concurs with the preference expressed in the comment, and is of the opinion that the proposed radius area will reduce complexity and will be of more practical benefit to the aeronautical public. Therefore, action is taken herein to designate the 700-foot portion of the Santa Fe transition area within a 10-mile radius of the Santa Fe Municipal Airport, including a south extension.

The substance of the proposed amendments having been published and for the reasons stated herein and in the Notice, the following actions are taken:

1. In Section 71.171 (27 F. R. 220-91, November 10, 1962), the Santa Fe, N. Mex., control zone is amended to read:

Santa Fe, N. Mex.

Within a 5-mile radius of the Santa Fe County Municipal Airport (Lat. $35^{\circ} 37' 00''$ N, Long. $106^{\circ} 05' 25''$ W); within 2 miles each side of the extended centerline of runway 20, extending from the 5-mile radius zone to 5 miles SW of the SW end of runway 20; and within 2 miles each side of the Santa Fe VORTAC 007° radial, extending from the 5-mile radius zone to 11 miles N of the VORTAC.

2. Section 71.181 (27 F. R. 220-139, November 10, 1962) is amended by adding the following:

Santa Fe, N. Mex.

That airspace extending upward from 700 feet above the surface within a 10-mile radius of the Santa Fe County Municipal Airport (Lat. $35^{\circ} 37' 00''$ N, Long. $106^{\circ} 05' 25''$ W), within 2 miles each side of the Santa Fe VORTAC 165° radial, extending from the 10-mile radius area to 8 miles S of the VORTAC; and that airspace extending upward from 1,200 feet above the surface bounded by a line beginning at Lat. $35^{\circ} 14' 00''$ N, Long. $106^{\circ} 02' 05''$ W; thence counterclockwise along the arc of a 46-mile radius circle centered on the Albuquerque VORTAC; to Lat. $35^{\circ} 37' 35''$ N, Long. $106^{\circ} 24' 48''$ W; to Lat. $35^{\circ} 47' 00''$ N, Long. $106^{\circ} 15' 00''$ W; to Lat. $35^{\circ} 47' 00''$ N, Long. $105^{\circ} 50' 00''$ W; to Lat. $35^{\circ} 14' 00''$ N, Long. $105^{\circ} 50' 00''$ W; to point of beginning, excluding the portion within R-5101.
