PART 71-DESIGNATION OF FEDERAL AIRWAYS,  
CONTROLLED AIRSPACE AND REPORTING POINTS (NEW)

Designation of Positive Control Area

On March 15, 1963, a Notice of Proposed Rule Making was published in the Federal Register (28 F. R. 2530) stating that the Federal Aviation Agency (FAA) proposed to designate as positive control area the airspace from flight level 240 to and including flight level 600 in portions of the areas of jurisdiction of the Phoenix, Albuquerque and Salt Lake City air route traffic control centers.

The Air Transport Association of America endorsed the proposal. The Department of the Navy concurred in the action and submitted for consideration comments on the operational requirements. No other comments were received.

Interested persons have been afforded an opportunity to participate in the making of the rule herein adopted, and due consideration has been given to all relevant matter presented.

The substance of the proposed amendment having been published, therefore, and for the reasons stated in the Notice, the following action is taken:

In Section 71.193 (27 F. R. 220-157, November 10, 1962) the following is added:

Phoenix, Ariz.

That airspace within the continental control area from flight level 240 to and including flight level 600, bounded by a line beginning at:

" " Lat. 34° 11' 00" N, Long. 113° 30' 00" W;

" " Lat. 35° 23' 00" N, Long. 112° 40' 00" W;  
" " Lat. 35° 26' 00" N, Long. 112° 00' 00" W;  
" " Lat. 37° 15' 00" N, Long. 112° 00' 00" W;  
" " Lat. 37° 48' 00" N, Long. 110° 46' 00" W;  
" " Lat. 38° 08' 00" N, Long. 106° 38' 00" W;  
" " Lat. 36° 43' 00" N, Long. 106° 05' 00" W;  
" " Lat. 35° 26' 00" N, Long. 110° 00' 00" W;  
" " Lat. 31° 20' 00" N, Long. 110° 00' 00" W;

thence westward along the U. S./Mexican border to the point of beginning.

This amendment shall become effective 0201 EST, July 25, 1963 except that implementation of positive control in the portion south of Lat. 35° 26' 00" N will not commence until 0201 EST, August 22, 1963.
