ANNUAL EXPERIENCE REPORTS

Currently effective Part 51 requires holders of ground instructor certificates to transmit to the Administrator, annually, during the month of January, a report for the preceding 12-month period, setting forth the amount and type of their aeronautical experience and such other pertinent data as the Administrator may require. The Board has been advised that these reports no longer serve the purpose for which they were intended and that the Administrator can effectively obtain the information furnished by these reports from the individuals themselves in the event of need. In this connection it should be noted that revised Part 25 which we recently adopted does not require the filing of annual experience reports by parachute riggers.

Interested persons have been afforded an opportunity to participate in the making of this amendment, and due consideration has been given to all relevant matter presented. Since this amendment imposes no additional burden on any person, it may be made effective without prior notice.

In consideration of the foregoing the Civil Aeronautics Board hereby amends Part 51 of the Civil Air Regulations (14 CFR, Part 51, as amended) effective immediately.
