STATUS OF CIVIL AIR REGULATIONS AND CIVIL AERONAUTICS MANUALS

The Civil Air Regulations are no longer sold separately and the Civil Aeronautics Manuals are no longer to be sold in Volumes, as in the past.

Under a new issuance system, each GAR and corresponding CAM will be incorporated into a single publication bearing the designation CIVIL AERONAUTICS MANUAL followed by the appropriate number. The change-over to this system is nearly completed.
