STATUS OF CIVIL AERONAUTICS MANUALS

The Civil Air Regulations and the Civil Aeronautics Manuals are no longer available separately but are now consolidated and sold as CIVIL AERONAUTICS MANUALS (CAMs), and bear the same numerical designations as in the past. Revisions, additions, deletions, and other changes are made by the issuance of supplements to the CAMs.

CAMs for which there is a wide demand and which are amended more frequently are sold on subscription; supplements to these are furnished to subscribers automatically by GPO as they are issued.

All other CAMs are sold without subscription service; supplements are available individually for a nominal charge for each. For your convenience, an order form requesting that GPO notify you when supplements are issued is included in each of these CAMs.
