FEDERAL AVIATION REGULATIONS [NEW] AND CIVIL AERONAUTICS MANUALS

The present Federal Aviation Agency regulatory system, which embraces the Civil Air Regulations, Special Civil Air Regulations, Civil Aeronautics Manuals, Regulations of the Administrator, etc., is being revised to reflect the consolidation of rule-making authority effected by the Federal Aviation Act of 1958.

The recodification program is designed to restate the rules and regulatory materials by adopting a straight subject matter arrangement of Parts called FEDERAL AVIATION REGULATIONS (FARs). An outline of this program is given in the appendix to new Part 1 of the FARs. Recodification is expected to be completed by late 1963.

In the interim, the old regulations and CAMs will remain in effect until superseded by new FARs. On the effective date of each new FAR, the old regulation or CAM will become obsolete and should be replaced in your files.

The FARs will NOT be sold on subscription. Mailing list service for all changes to the FARs will be furnished free of charge by the FAA *on request*. An order form for this purpose is included in each new FAR.

For your convenience, we list the status of Civil Aeronautics Manuals and of the new Federal Aviation Regulations as of the above date. Where a CAM has been superseded by an FAR, we have so indicated.
