This Web-based training is a basic introduction to FHWA's NEPA transportation decisionmaking process that takes into account the potential impacts of transportation projects on the human and natural environment balanced with the public's need for safe and efficient transportation. The training covers NEPA requirements as implemented by the Council on Environmental Quality, as well as FHWA's regulations and guidance for NEPA implementation and project decisionmaking. Topics include purpose and need, alternatives development and analysis, impact analysis, public involvement, interagency coordination, mitigation, and documentation. NHI strongly recommends completion of this self-paced training prior to enrolling in the Instructor-led training 142005 NEPA and Transportation Decisionmaking.


