#### **USDOT Seeks Public Comment on Draft Strategic Plan**

The *U.S. Department of Transportation* (DOT) invites the public to comment on the [draft DOT Strategic Plan for FY 2018-2022](#). The draft reflects Transportation Secretary Elaine L. Chao's priorities for achieving DOT's mission through safety, infrastructure investment, innovation, and accountability. The deadline to submit comments is Monday, November 13, 2017.

#### **"Accessible Shared Streets: Notable Practices and Considerations for Accommodating Pedestrians with Vision Disabilities"**

The *Federal Highway Administration* (FHWA) published a new report, titled ["Accessible Shared Streets: Notable Practices and Considerations for Accommodating Pedestrians with Vision Disabilities."](#) The report discusses strategies for designing streets that improve accessibility for pedestrians with vision disabilities, particularly on streets in which pedestrians, bicyclists, and motor vehicles are intended to mix in the same space.

#### **America Walks Announces Community Change Grants**

*America Walks* will award up to \$1,500 each in [Community Change Grants](#) to help catalyze small-scale, low-cost projects and programs that focus on walking. Winning projects will increase the prevalence of walking, expand the diversity of people and organizations working to advance walkability, and help to make walking safer, easier, and more fun for all community members. The application deadline is November 10, 2017.

#### **Walk Friendly Communities Awards Eight Walk Friendly Designations**

The *Walk Friendly Communities* program recognized eight communities with new and renewed Walk Friendly Designations. The recognition indicates that these communities have made a commitment to prioritize pedestrians by creating safe, inviting places to walk. The recognized communities include Washington, DC; Columbus, OH; Long Beach, CA; Redwood City, CA; Essex Junction, VT; Gainesville, FL; Northampton, MA; and Sitka, AK.

#### **Call for Completed Bike Infrastructure**

The *Rethinking Streets Project* is soliciting examples of completed street or intersection retrofits for possible inclusion in a new book project, "Rethinking Streets for Bikes." This project builds on the success of the original effort, "Rethinking Streets: An Evidence-Based Guide to 25 Complete Street Transformations." The new book will be available for free download.
