#### Presidential Executive Order on Accountability in the Environmental Review and Permitting Process

On August 15, President Donald J. Trump signed a <u>"Presidential Executive Order on Establishing Discipline and Accountability in the Environmental Review and Permitting Process for Infrastructure.</u>" The Presidential Executive Order is meant to strengthen America's infrastructure by streamlining the process for environmental review and permitting and accelerating project delivery. The Presidential Executive Order emphasizes that increased infrastructure investment would create jobs and increase wages, which would thereby strengthen quality-of-life in communities across the Country.

#### "Traffic Monitoring: Automobiles, Trucks, Bicycles, and Pedestrians"

The *Transportation Research Board* (TRB) published "Journal of the <u>Transportation Research Board No. 2644,</u>" which consists of 13 papers exploring issues related to traffic monitoring, such as bicycle and pedestrian counts at signalized intersections and costs of independent multimodal projects.

#### America Walks Highlights 2016 Micro Grant Recipients

America Walks partnered with the Every Body Walk! Collaborative to launch a Micro Grant Program, and in December 2016, the organization awarded grants to 22 organizations. Recently, America Walks has released some <u>case studies</u> to highlight how these organizations are leveraging these grants to implement strategic changes to transform walking in their communities.

#### September 30: National Bike Your Park Day

September 30, 2017 is the second annual <u>Bike Your Park Day</u>. *Adventure Cycling* reports that over 550 rides with more than 3,000 participants in across the United States and internationally are registered to bike to their parks and other recreational destinations. Bike Your Park Day encourages individuals to explore parks and public lands in rural and urban settings; the event will include special activities and service projects.
