"The Best Complete Streets Policies of 2016"

The *National Complete Streets Coalition* released "[The Best Complete Streets Policies of 2016](#)," which celebrates the accomplishments of communities with successful Complete Streets policies. In 2016, 222 communities adopted new Complete Streets policies. A total of 1,232 policies are now in place in all 50 States, Puerto Rico, and the District of Columbia. All of the communities were given scores out of 100 for their policies, and Brockton, MA; Missoula, MT; and Wenatchee, WA all received perfect scores of 100 for their Complete Streets policies.
