Example:

If this location reported **253 shipments in Item D1**, it would correspond to the range of **241-280** and every **7th** outbound shipment record would be selected.

This means:

- 1. The location would count **7 records**, starting with the first shipment record of the week that was identified in Item D1, select that record and report it in Item F.
- 2. The location would then count **another 7 records** again from the shipment selected in step 1 and record that shipment in Item F.
- 3. The location would repeat this process until it had gone through the full set of shipment records for the week identified in Item D1.
- 4. The location would report 36 shipments in Item F. Item F contains 80 lines, so the location would leave lines 37-80 blank.
