Civil Aeronautics Manual 43

The Federal Aviation Agency has issued a new Part 61--Certification: Pilots and Flight Instructors, to become effective November 1, 1962, which partially supersedes Civil Aeronautics Manual 43, General Operations Rules, dated September 1959. New Part 61 is available from this Office at 30 cents per copy, as indicated on the enclosed order form.

The issuance of this new Part is in line with FAA's program, announced in November 1961, to recodify its Civil Air Regulations, Civil Aeronautics Manuals, and Regulations of the Administrator and develop a new single regulatory system of Federal Aviation Regulations. A Distribution Table relating the present CAM/CAR Part numbers with the new Part numbers and target dates for issuance of new Parts are published in Part 1--Definitions and Abbreviations [New]. Part 1 was mailed to you in June 1962.

The sections of CAM 43 affected by the new Part 61 have been deleted and correct references supplied by the enclosed Supplement No. 7. The new Part 91, scheduled for issuance in December 1962, will supersede more of CAM 43, which will be reflected in another supplement. You will be notified of the availability and price of the new Part 91 at that time. New Part 41, scheduled for issuance in August 1963, will supersede the remaining portions

in CAM 43. You will receive a Special Notice announcing the availability and price of the new Part 41. This will complete your subscription to Civil Aeronautics Manual 43.

All new basic FAR Parts will be sold by the Superintendent of Documents. Changes will be sent free to those who send FAA the Order Blank included in each new regulation.
