APPENDIX C

Civil Aeronautics Manual 52

REGIONAL OFFICES AND AREAS OF JURISDICTION

- Region 1, with Headquarters Office at Jamaica, Iong Island, N. Y., shall be composed of the States of Maine, New Hampshire, Vermont, Massachusetts, Rhode Island, Connecticut, New York, Delaware, New Jersey, Pennsylvania, Ohio, Maryland, Virginia, West Virginia, Kentucky, and the District of Columbia.
- Region 2, with Headquarters Office at Fort Worth, Texas, shall be composed of the States of Tennessee, North Carolina, South Carolina, Georgia, Florida, Alabama, Mississippi, Arkansas, Oklahoma, Louisiana, and Texas, and Puerto Rico, Swan Island, the Virgin Islands, and the Canal Zone.
- Region 3, with Headquarters Office at Kansas City, Missouri, shall be composed of the States of Michigan, Indiana, Wisconsin, Illinois, Minnesota, Iowa, Missouri, North Dakota, South Dakota, Nebraska, and Kansas.
- Region 4, with Headquarters Office at Los Angeles, California, shall be composed of the States of Montana, Wyoming, Colorado, New Mexico, Arizona, Utah, Idaho, Washington, Oregon, Nevada, and California.
- Region 5, with Headquarters Office at Anchorage, Alaska, shall consist of the Territory of Alaska, including the Aleutian Islands.
- Region 6, with Headquarters Office at Honolulu, T. H., shall consist of the areas contained within the Honolulu, Wake, and Guam Flight Information Regions established by ICAO. (Major operations are conducted in the Territory of Hawaii and the islands of Canton, Wake, and Guam.)
