Notice to FAA Holders of Volume III of the CAM's

December 15, 1959

SUBJECT: New Issuance System for Volume III Manuals.

The FAA has recently inaugurated an individual issuance system for the Civil Aeronautics Manuals. They will no longer be grouped in volumes. Each manual will be issued separately and will contain both the pertinent Civil Air Regulation and any related CAM material.

Civil Aeronautics Manual 18 (dated February 1957) as included in Volume III, and amended by supplements 1, 2, 4, 6, 7, 8, and 9 to Volume III, is up to date except for editorial corrections to change CAA to FAA.

In view of this fact, CAM 18 will not be reprinted at this time. However, to facilitate the breaking down of the volume issuance system of the CAM's, we are providing a new FAA cover to replace the CAA cover dated February 1957. This new cover is dated December 15, 1959, and the next change to this manual will be issued as Supplement No. 1 to CAM 18. Also, references to CAA will be changed to FAA, where appropriate, as page revisions to CAM 18 are issued.

Civil Aeronautics Manual 24, which was formerly issued by the CAA as part of Volume III, is being revised and copies will be available concurrently with the issuance of this notice. Therefore, CAM 24, dated January 1957, should be removed from Volume III and destroyed.

Introductory Note

This manual contains in consolidated form (1) Civil Air Regulations Part 18, Maintenance, Repair, and Alteration of Airframes, Powerplants, Propellers, and Appliances, dated July 17, 1956, Amendments 18-1, 18-2, and Special Civil Air Regulation SR-377A; and (2) the rules, policies, and interpretations issued by the Administrator of the Federal Aviation Agency in application to the various sections of the regulations.

FAA *rules* are supplementary regulations issued pursuant to authority expressly conferred on the Administrator in the Civil Air Regulations. Such rules are mandatory and must be complied with.

FAA *policies* provide detailed technical information on recommended methods of complying with the Civil Air Regulations. Such policies are for the guidance of the public and are not mandatory in nature.

FAA *interpretations* define or explain words and phrases of the Civil Air Regulations. Such interpretations are for the guidance of the public and will be followed by the Agency in determining compliance with the regulations.

The manual is arranged to give the number, title, and text of each section of the regulations followed by any rules, policies, or interpretations applicable to that section. The rules, policies, or interpretations of the Administrator are identified by consecutive numbers appended by a dash to the regulation section number.

This manual supersedes Civil Aeronautics Manual 18 dated February 1957 and all supplements. As amendments and other pertinent material pertaining to Part 18 are issued, they will be included in this manual.

References to CAA will be changed to FAA where appropriate as page revisions to this manual are issued.


SUBJECT: Revisions to Civil Aeronautics Manual 18 dated February 1957.

Appropriate reference changes have been made in the titles of sections 18.1-1 through 18.1-6.


