Subject: STATUS OF FEDERAL AVIATION REGULATIONS

1. PURPOSE.

This circular provides the public with the current publication status of the Federal Aviation Regulations (FARs), prices, and order forms.

2. CANCELLATION.

AC 00-44CC dated August 1991, is cancelled.

3. HOW TO ORDER.

- a. Enclosed are two order forms, one for subscription orders and the other for publication orders.
- b. Appendix 1 lists the FAR parts sold as publication orders (single-sale basis); Appendix 2 lists the FAR parts sold as subscription orders. The Special Federal Aviation Regulations (SFARs) which are presently in effect are included in their related FAR parts. The listing of SFARs is included in this Advisory Circular as Appendix 3.
- c. Federal Aviation Regulations are sold by the Superintendent of Documents. FAR parts having frequent changes are sold on subscription (use *subscriptions* order form). Parts which are changed less frequently are sold on a single-sale basis and changes to these parts are sold separately (use *publication* order form).
