Subject: STATUS OF FEDERAL AVIATION REGULATIONS

1. PURPOSE.

This circular sets forth the current publication status of the Federal Aviation Regulations, any Changes issued to date, and provides a price list and ordering instructions.

2. CANCELLATION.

AC 00-44T dated November 15, 1982, is cancelled.

3. PRINCIPAL CHANGES.

The Special Federal Aviation Regulations (SFARs) which are presently in effect are included in their related FAR Parts. The listing of SFARs is included in this Advisory Circular as Appendix 3.

4. HOW TO ORDER.

- a. Federal Aviation Regulations are sold by the Superintendent of Documents. Send orders for FARs to the Superintendent of Documents, U.S. Government Printing Office, Washington, D.C. 20402. A check or money order payable to the Superintendent of Documents must be included with the order. The prices of all FAR publications are listed in Appendixes 1 and 2.
- b. Only Parts having frequent Changes are sold on subscription. Parts which are changed less frequently are sold on a single-sale basis and Changes to these Parts are sold separately.
- c. To expedite your order, prepare separate lists for subscription items and single-sale items. Include the Part number, title, and catalog or stock number, as appropriate, for each item ordered. Submit each list separately with the correct remittance attached. Include your name and address on each list because subscription and nonsubscription orders are separated for processing when received by the Superintendent of Documents.
- d. Prices shown were in effect on the date indicated on this list. Government documents' prices are subject to change without prior notice; therefore, the price in effect when your order is processed will be the price charged for each publication ordered.

5. FAA INTERNAL DISTRIBUTION.
