# ADVISORY CIRCULAR

## DEPARTMENT OF TRANSPORTATION FEDERAL AVIATION ADMINISTRATION

**SUBJECT:** ANNOUNCEMENT AND INVITATION - FAR  
PART 135 REGULATORY REVIEW PROGRAM

---

1. PURPOSE. This Advisory Circular announces that the Federal Aviation Administration (FAA) will convene a Part 135 Regulatory Review Conference at the Stouffer Denver Inn, East 32nd and Quebec Street, Denver, Colorado 80207, telephone: 303/321-3333. The Stouffer Inn is located near the entrance of Stapleton International Airport, and is less than two miles from Interstate Highways. The conference dates are November 8 through 12, 1976.
  2. BACKGROUND. The Part 135 Regulatory Review Program was established to conduct a general upgrading of Part 135. The Flight Standards Service of FAA developed 112 proposals for discussion at the conference, many of which came from sources outside of FAA. These proposals were distributed in September to all listed air taxi operators. Copies are also available as long as the supply lasts for other interested persons upon request.
  3. DISCUSSION.
    - a. The Part 135 Regulatory Review is designated to expedite the traditional "one by one" method of amending rules. Necessary regulatory changes will be made in a timely and orderly manner with public and industry participation. The proposals developed for the upgrading process and distributed to listed air taxi operators in the form of a workbook, will be used for discussion by participating persons at the conference. The discussions will be limited to Part 135 and one section of Part 121.
    - b. The Stouffer Denver Inn will make available to conferees at least 200 guest rooms and suites for the occasion. Additional rooms probably will be available. All meetings will take place in the conference facilities within the hotel. The surrounding area contains other hotels convenient to the meeting site, with ample guest rooms available. Parking at the site for 500 cars and a courtesy shuttle bus is available for transportation between the Inn and Stapleton Airport every ten minutes. Transportation from other motels can be arranged for conferees

not accommodated at the Stouffer Inn. For those who plan to attend, it is suggested that reservations be confirmed at an early date to assure onsite lodging. Guest room reservations should be made by writing directly to the hotel giving the meeting title and dates. (FAA-Part 135 Regulatory Review Conference, November 8 through 12, 1976). A blank registration form for this purpose is available from the Stouffer Inn and was included in the Appendix of the workbook.

- c. There will be no admission fee or other charge to attend and participate in the conference sessions. All scheduled sessions will be open to the public as long as space is available. The FAA cordially invites interested persons to attend.
