- 2. CANCELLATION. Advisory Circular No. 149-2, canceled.
- 3. <u>REFERENCES</u>. The FAA certification requirements for parachute lofts are set forth in Part 149 of the Federal Aviation Regulations.
- 4. <u>REVISION</u>. During a six-month period, FAA certificates are acquired or dropped by parachute lofts. This revision will advise the public of such current status.
