- This circular announces the publication, AIRPORT ACTIVITY 1. STATISTICS OF CERTIFICATED ROUTE AIR CARRIERS, covering the twelve months ended June 30, 1962.
- DESCRIPTION OF THE PUBLICATION. 2.
 - This publication contains the basic statistics on aircraft departures and on-line revenue traffic, passenger, freight, express, and mail, at each of the airports served by U. S. airlines. The airport activity data are classified into three categories: system operations, domestic operations, and international and territorial operations. All on-line airports reported at which aircraft departures were performed in scheduled service are included. This report provides these statistics in detail by air carrier, by community, by individual airport, and by aircraft type. The data are compiled from the information reported to the CAB, quarterly, by the certificated route air carriers on Schedule T-4, Airport Activity Data, CAB Form 41.
 - Form of Publication. This document, published jointly by the Civil Aeronautics Board and the Federal Aviation Agency, replaces the issuance by the CAB of its publication of the same title and by the FAA of its publication, AIR COMMERCE TRAFFIC PATTERN. Future editions will be published covering the 12 months ending December 31 and June 30 of each year.
