ADVISORY CIRCULAR

DEPARTMENT OF TRANSPORTATION FEDERAL AVIATION ADMINISTRATION

SUBJECT: ADDRESS LIST OF STATE OFFICES OF EMERGENCY MEDICAL SERVICES

1. PURPOSE. This advisory circular transmits the address list of all state offices of emergency medical services including those of the District of Columbia, Virgin Islands, Puerto Rico and Guam.
2. BACKGROUND. This publication serves as a document that can be used by the aviation public to establish contact with state offices of emergency medical services. It should be of particular benefit to the operators of airports certificated under Part 139 of the Federal Aviation Regulations who are required to address the matter of medical services in emergency plans. To the extent that state and local agencies can provide support in emergency medical services planning, airport operators should be able to develop and maintain more realistic and viable plans.
3. UPDATING. This address list will be updated as changes dictate, but not more often than once a year.
