ANNOUNCEMENT OF AVAILABILITY

Subject: AN AIRPORT FIREFIGHTER TRAINING FILM, "RED ALERT"

- 1. <u>PURPOSE</u>. This advisory circular explains the nature of the training film and tells how it can be obtained on loan for use as a training aid.
- 2. <u>FOCUS</u>. The training film is intended to serve as a basic orientation/training course in aircraft crash, firefighting, and rescue operations for airport and other fire service employees with little or no formal training in crash, fire, and rescue (CFR) activities. This training film highlights the knowledge and operational skills required for safe CFR activities and seeks to motivate viewers to obtain the level of detailed training appropriate to their airport environment.
- 3. <u>CANCELLATION</u>. Advisory Circular 150/5200-26, Announcement of Availability, An Airport Firefighter Training Film, "Red Alert," dated 6/15/79 is canceled.
- 4. BACKGROUND. The goals of this training film are:
- a. To dramatize the characteristics and the life hazard associated with liquid fuel fires.
- b. To acquaint airport employees and mutual aid fire department personnel having CFR service responsibilities with the various types of aircraft fuel fire extinguishing agents and application devices.
- c. To acquaint airport employees who are expected to engage in or supervise others in CFR operations with the range of safety equipment and tools required for personnel safety.
- d. To acquaint airport management with the need to provide special training for all personnel assigned CFR duties.
- e. To encourage the development of the skills and technical proficiency required to:
- (1) Select the equipment appropriate to their specific airport environment.

- (2) Use the equipment effectively during CFR emergencies.
- (3) Employ safe methods during firefighting and rescue operations and training exercises.
