ANNOUNCEMENT OF AVAILABILITY --

GUIDELINES FOR FEDERAL INSPECTION SERVICES FACILITIES AT INTERNATIONAL AIRPORTS OF ENTRY AND AT LANDING RIGHTS AIRPORTS

- This advisory circular announces the availability of the 1. booklet "Airports Within the United States - Guidelines for Federal Inspection Services Facilities."
- CANCELLATION. Advisory Circular 150/5360-4, Guidelines for Federal 2. Inspection Services at International Airports of Entry and at Landing Rights Airports, dated May 20, 1976, is cancelled.
- REFERENCES. Advisory Circular (AC) 00-2, Advisory Circular Checklist and Status of Federal Aviation Regulations (FARs), updated triannually, contains the listing of current issuances of advisory circulars and changes thereto. It explains the circular numbering system and gives instructions for ordering advisory circulars that are for sale as well as those distributed free of charge. AC 00-2 also gives instructions for ordering the Federal Aviation Regulations. - DESCRIPTION OF BOOKLET. This booklet contains guidance material on the design of airport terminal building facilities to accommodate the Federal Inspection Services (FIS) required for the processing of international traffic within the United States. The physical characteristics of the FIS area are discussed and delineated in terms of passenger and baggage flow and terminal buildings space utilization. Inspection facilities at international airports of entry and at landing rights airports are required in order to carry out the responsibilities

of the U. S. Customs Service of the Department of Treasury; the Immigration and Naturalization Service of the Department of Justice; the Animal and Plant Health Inspection Service of the Department of Agriculture; and the Public Health Service of the Department of Health, Education, and Welfare.
