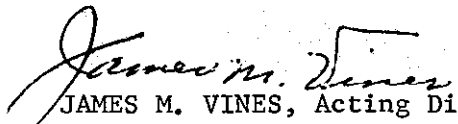
**SUBJECT:** FAA DESIGNATED PARACHUTE RIGGER EXAMINER DIRECTORY

1. PURPOSE. This advisory circular provides a revised directory of all FAA-designated parachute rigger examiners as of January 31, 1976.
2. CANCELLATION. Advisory Circular 183-31B dated April 2, 1974, is cancelled.
