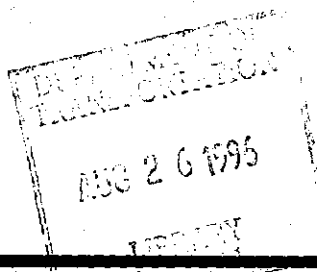

1. **PURPOSE.** This advisory circular (AC) transmits a consolidated directory of Designated Airworthiness Representatives (DAR's) for both Maintenance (appendix 1) and Manufacturing (appendix 2), Organizational Designated Airworthiness Representatives (ODAR's) for both Maintenance (appendix 3) and Manufacturing (appendix 4), Designated Alteration Stations (DAS's) (appendix 5), manufacturing organizations with Delegation Option Authorization (DOA's) (appendix 6), and organizations certificated under the provisions of SFAR Part 36 (appendix 7) as of January 23, 1996.
2. **CANCELLATION.** This AC cancels AC 183-35E, FAA DAR, DAS, DOA, and SFAR Part 36 Directory, dated March 28, 1994.
3. **FUNCTIONS.** The following is a list of functions each designee/representative may be authorized to perform. The codes following each name and address indicate authorized functions. Authorized functions may be limited by category, class, and type. Refer to the local district office for limitations for functions authorized.
 - 01 ISSUE ORIGINAL STANDARD AIRWORTHINESS CERTIFICATES FOR U.S.-REGISTERED AIRCRAFT, EXCLUDING AIRCRAFT BUILT FROM SPARE AND SURPLUS PARTS, SURPLUS MILITARY AIRCRAFT, OR FOREIGN MANUFACTURED AIRCRAFT IMPORTED FROM COUNTRIES OTHER THAN THE COUNTRY OF MANUFACTURE.
 - 02 ISSUE EXPERIMENTAL CERTIFICATES, FOR THE PURPOSE OF SHOWING COMPLIANCE WITH THE REGULATIONS, FOR U.S.-REGISTERED AIRCRAFT WHICH HAVE UNDERGONE CHANGES TO THE TYPE DESIGN AND REQUIRE FLIGHT TEST, PRIOR TO THE ISSUANCE/RE-ISSUANCE OF A STANDARD AIRWORTHINESS CERTIFICATE.
 - 03 ISSUE ORIGINAL RESTRICTED AIRWORTHINESS CERTIFICATES FOR U.S.-REGISTERED/U.S.-MANUFACTURED RESTRICTED-CATEGORY AIRCRAFT, LOCATED IN THE U.S. AND ITS POSSESSIONS ONLY, EXCLUDING AIRCRAFT BUILT FROM SPARE AND SURPLUS PARTS OR SURPLUS MILITARY AIRCRAFT.
 - 04 ISSUE ORIGINAL/RECURRENT EXPERIMENTAL CERTIFICATES FOR U.S.-REGISTERED, AMATEUR-BUILT AIRCRAFT, LOCATED IN THE U.S. AND ITS POSSESSIONS ONLY.
 - 05 ISSUE SPECIAL FLIGHT PERMITS FOR U.S.-REGISTERED AIRCRAFT FOR THE PURPOSES OUTLINED UNDER TITLE 14 OF THE CODE OF FEDERAL REGULATIONS (14 CFR) IN SECTION 21.197(A) (1) THROUGH (5), EXCLUDING THE ISSUANCE OF SUCH PERMITS FOR ANY OVERWEIGHT OPERATION.

- 06 ISSUE ORIGINAL EXPORT AIRWORTHINESS APPROVALS FOR CLASS I PRODUCTS (I.E., AIRCRAFT, AIRCRAFT ENGINES, OR PROPELLERS) IN ACCORDANCE WITH THE PROVISIONS OF 14 CFR PART 21, SUBPART L; EXCLUDING AIRCRAFT BUILT FROM SPARE AND SURPLUS PARTS OR SURPLUS MILITARY AIRCRAFT.
- 07 ISSUE ORIGINAL EXPORT AIRWORTHINESS APPROVALS FOR CLASS II PRODUCTS (I.E., MAJOR COMPONENTS OF A CLASS I PRODUCT) THAT ARE MANUFACTURED AND LOCATED IN THE UNITED STATES IN ACCORDANCE WITH THE PROVISIONS OF 14 CFR PART 21, SUBPART L.
- 08 MAKE CONFORMITY DETERMINATIONS ON AIRCRAFT AND PARTS THEREOF (INCLUDING PROTOTYPE AIRCRAFT, TEST ARTICLES, AND INSTALLATIONS) TO BE USED FOR DESIGN EVALUATION PROGRAMS; E.G., TYPE CERTIFICATE AND SUPPLEMENTAL TYPE CERTIFICATE PROGRAMS.
- 09 ISSUE CONFORMITY CERTIFICATIONS ON BEHALF OF FOREIGN CIVIL AIR AUTHORITIES FOR COMPONENTS MANUFACTURED BY U.S. SUPPLIERS FOR FOREIGN PRODUCT MANUFACTURERS, AFTER MAKING DETERMINATIONS OF CONFORMITY TO THE DESIGN, TEST, AND QUALITY REQUIREMENTS NOTIFIED TO THE FAA BY THE CIVIL AIR AUTHORITY OF THE COUNTRY IN WHICH THE PRODUCT MANUFACTURER IS LOCATED.
- 10 ISSUE RECURRENT STANDARD AIRWORTHINESS CERTIFICATES FOR U.S.-REGISTERED AIRCRAFT; EXCEPT FOREIGN MANUFACTURED AIRCRAFT IMPORTED FROM COUNTRIES OTHER THAN THE COUNTRY OF MANUFACTURE.
- 11 ISSUE RECURRENT RESTRICTED AIRWORTHINESS CERTIFICATES FOR U.S.-REGISTERED/U.S.-MANUFACTURED RESTRICTED-CATEGORY AIRCRAFT LOCATED IN THE U.S. AND ITS POSSESSIONS ONLY.
- 12 ISSUE RECURRENT/ORIGINAL EXPERIMENTAL CERTIFICATES FOR U.S.-REGISTERED, AMATEUR-BUILT AIRCRAFT LOCATED IN THE U.S. AND ITS POSSESSIONS ONLY.
- 13 ISSUE SPECIAL FLIGHT PERMITS FOR U.S.-REGISTERED AIRCRAFT FOR THE PURPOSES OUTLINED IN 14 CFR SECTION 21.197(A) (1) AND (2), EXCLUDING THE ISSUANCE OF SUCH PERMITS FOR ANY OVERWEIGHT OPERATION.
- 14 ISSUE RECURRENT EXPORT AIRWORTHINESS APPROVALS FOR CLASS I PRODUCTS (I.E., AIRCRAFT, AIRCRAFT ENGINES, OR PROPELLERS) IN ACCORDANCE WITH THE PROVISIONS OF 14 CFR PART 21, SUBPART L.
- 15 ISSUE RECURRENT EXPORT AIRWORTHINESS APPROVALS FOR CLASS II PRODUCTS (I.E., MAJOR COMPONENTS OF A CLASS I PRODUCT) THAT ARE MANUFACTURED AND LOCATED IN THE UNITED STATES IN ACCORDANCE WITH THE PROVISIONS OF 14 CFR PART 21, SUBPART L.
- 16 ISSUE ORIGINAL, SPECIAL-PROVISIONAL AIRWORTHINESS CERTIFICATES.
- 17 ISSUE ORIGINAL, EXPORT AIRWORTHINESS APPROVALS FOR CLASS III PRODUCT MANUFACTURED AND LOCATED IN THE UNITED STATES ONLY.
- 18 ISSUE SUPPLEMENTAL TYPE CERTIFICATES.
- 19 ISSUE EXPERIMENTAL AIRWORTHINESS CERTIFICATES FOR RESEARCH AND DEVELOPMENT.

- 20 ISSUE EXPERIMENTAL AIRWORTHINESS CERTIFICATES FOR CREW TRAINING.
- 21 ISSUE EXPERIMENTAL AIRWORTHINESS CERTIFICATES FOR MARKET SURVEY.
- 22 AMEND STANDARD AIRWORTHINESS CERTIFICATES FOR U.S.-REGISTERED AIRCRAFT.
- 23 ISSUE EXPERIMENTAL AIRWORTHINESS CERTIFICATES TO SHOW COMPLIANCE WITH TITLE 14 OF THE CODE OF FEDERAL REGULATIONS.
