2. CANCELLATION. Advisory Circular 20-126E, Aircraft Certification Service Field Office Listing, dated January 17, 1995, is canceled.

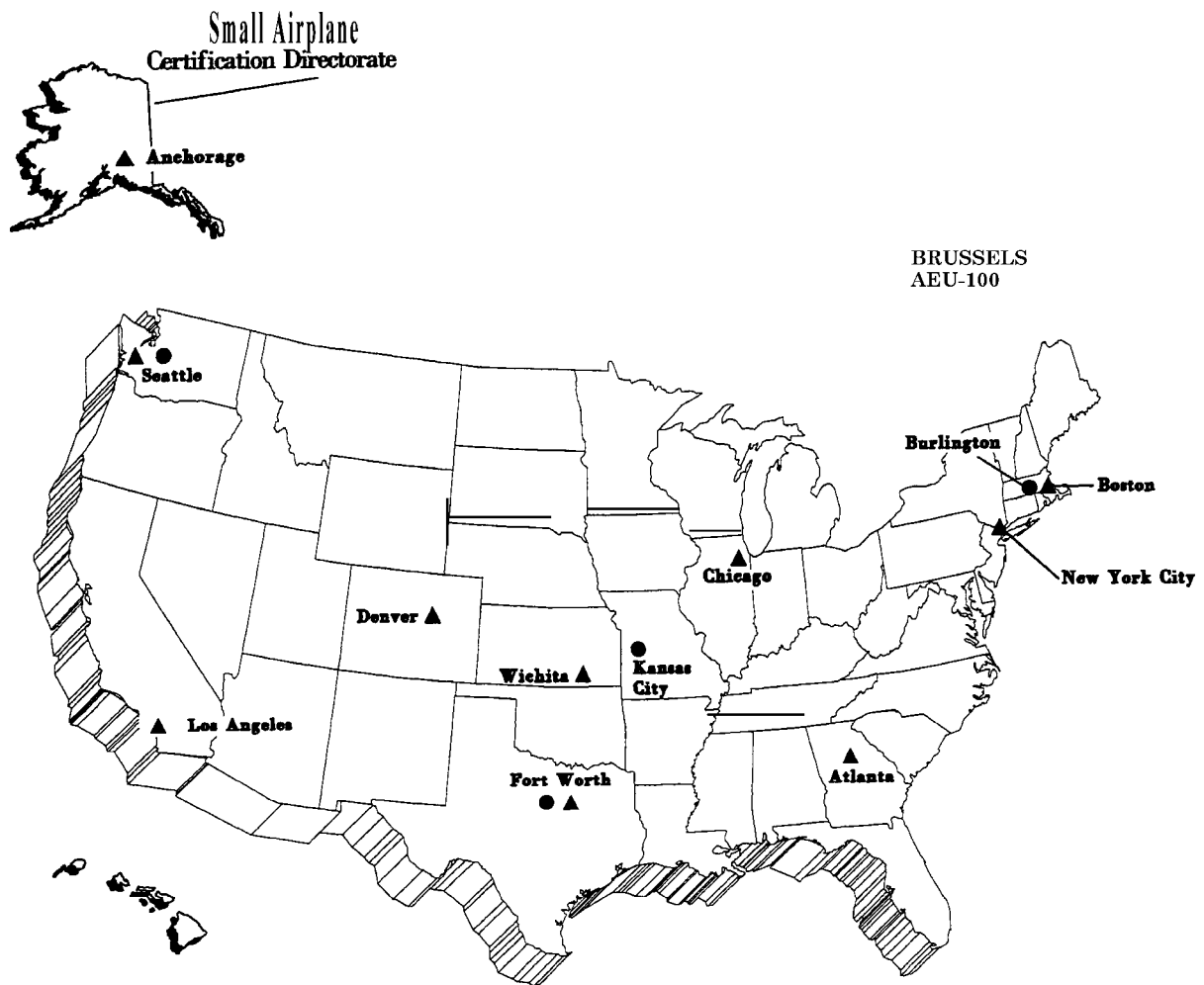

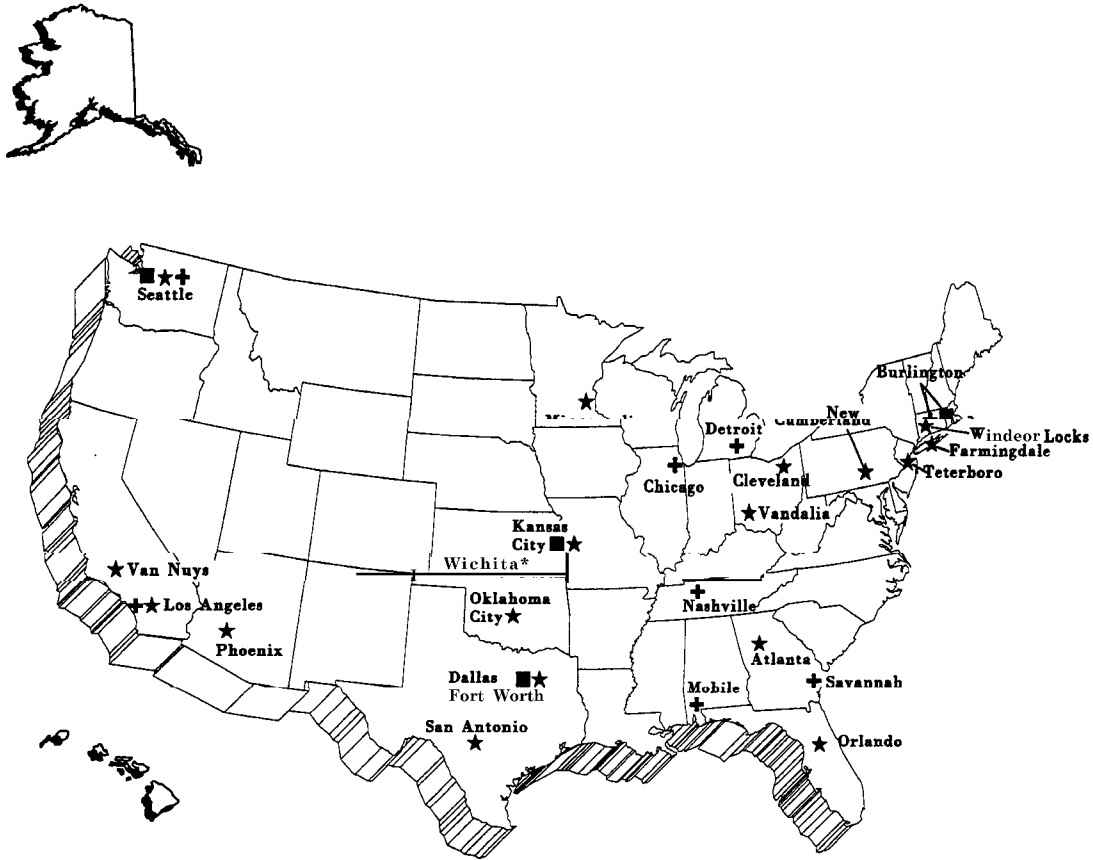
