SUBJECT: TECHNICAL INFORMATION REGARDING CIVIL AERONAUTICS MANUALS 1, 3, 4a, 4b, 5, 6, 7, 9, 13, and 14

- 1. PURPOSE. This circular is to advise the public that such policy information as is contained in Civil Aeronautics Manuals 1,3, 4a, 4b, 5, 6, 7, 9, 13, and 14 may be used in conjunction with specific sections of the Federal Aviation Regulations which correspond with the sections of the Civil Air Regulations to which the policies are applicable, upon recodification effective February 1, 1965.
- 2. CANCELLATION. AC No. 20-33 dated 2/8/65 is cancelled. The reference to CAM 8 and CAM 10 has been deleted since CAM 8 will be replaced by an Advisory Circular and CAM 10 has been made obsolete by FAR 21.29.

3. INFORMATION.

- a. Civil Aeronautics Manual policies provide detailed technical information on acceptable methods of complying with the regulations. Such policies are for the guidance of the public and are not mandatory.
- b. CAMs covering the certification of products should not be discarded by interested persons upon recodification, because the rules contained therein, and accompanying policies, will continue to apply to products which have been certificated thereunder.

c. Policies applicable to sections of the Federal Aviation Regulations will be contained in the future Advisory Circular issuances, which will update and replace the CAM materials.
