DEPARTMENT OF TRANSPORTATION FEDERAL AVIATION ADMINISTRATION

SUBJECT: UNITED STATES CIVIL AIRCRAFT REGISTER

1. **PURPOSE.** This circular announces the availability of the latest issue of the U.S. Civil Aircraft Register, Advisory Circular 20-6T, dated January 1, 1973.
2. **DESCRIPTION.** The subject advisory circular is published semi-annually and is a timely and clearly presented issuance in book form. The current edition is in two volumes. It lists all registered U.S. civil aircraft for which a completed Aircraft Registration Eligibility, Identification and Activity Report (AC Form 8050-73) has been submitted by the owner and found acceptable in compliance with Section 47.44 of the Federal Aviation Regulations, or for which new registration has been effected during this period.

The register's listing of aircraft is arranged in numeric sequence by registration mark (N-number). The following details are given for each aircraft: name and address of registrant, manufacturer's serial number, make and model, year manufactured and type of registrant.

3. **OBTAINING COPIES.** In addition to the mail order service provided by the Office of the Superintendent of Documents, U.S. Government Printing Office, Division of Public Documents, Washington, D.C. 20402, there are also Government retail bookstores where copies of AC 20-6T may be ordered and/or purchased across the counter. Locations of the GPO bookstores are given in Appendix 1.
4. **MAIL ORDER PURCHASING.** An order form is enclosed for your convenience (see Appendix 2).
 - a. Identify the publication in your order as AC 20-6T, U.S. Civil Aircraft Register.

- b. Enclose a check, money order, or Superintendent of Document coupons with your order. Checks or money orders should be made payable to the Superintendent of Documents in the amount of \$15.35 per set (postpaid). The current register is sold in sets only.
