SUBJECT: FINAL ANNOUNCEMENT - THE SIXTH ANNUAL FAA INTERNATIONAL AVIATION MAINTENANCE SYMPOSIUM

- 1. <u>PURPOSE</u>: This will notify the public that this is the final announcement and invitation to this annual event.
- 2. CANCELLATION: AC 65-10, dated April 1, 1970.
- 3. DETAILS OF THE SYMPOSIUM: The Federal Aviation Administration will convene its Sixth Annual Aviation Maintenance Symposium at the Skirvin Hotel in Oklahoma City, Oklahoma, on December 8, 9, and 10, 1970. INTERNATIONAL has been added to the title this year to recognize the many foreign countries who have actively shared their technical developments in the past five symposiums.
 - a. The past symposiums in this series have provided an opportune time and place for an open exchange of information between the manufacturers owners, operators, maintenance organizations, maintenance technicians, service engineers, governments, managers, and others who are involved in aviation maintenance or related activities. The 2 1/2-day event will be scheduled for the presentation of selected papers and related panel discussions in five sessions. The symposium will close at noon on the third day to accommodate travel requirements of the attendees.
 - b. The theme of this event is THE AVIATION MAINTENANCE ENVIRONMENT IN THE 70's and will encompass new maintenance developments within the entire aviation spectrum. This will include maintenance concepts and plans for airframes, systems, powerplants, accessories, devices, avionics and electronics, and associated processes. In this decade, we are confronted with environmental considerations relating to air taxi operations, STOL aircraft, wide-body transport aircraft, air pollution, and noise. These factors have motivated the need to generate new approaches for the continued operation of aircraft of all proportions within this environment. The theme lends itself to diversified presentations affecting both air carrier and general aviation interests.
