SUBJECT: FINAL ANNOUNCEMENT - THE SEVENTH ANNUAL FAA INTERNATIONAL AVIATION MAINTENANCE SYMPOSIUM

- 1. <u>PURPOSE</u>. This will notify the public that this is the final announcement and invitation to this annual event.
- 2. DETAILS OF THE SYMPOSIUM. The Federal Aviation Administration will convene its Seventh Annual International Aviation Maintenance Symposium at the Skirvin Hotel in Oklahoma City, Oklahoma, on 7, 8, and 9 December 1971.
 - a. The symposium will provide an opportunity for an open exchange of information between manufacturers, owners, operators, air carriers, maintenance organizations, technicians, service engineers, government, and others involved in aviation maintenance and related activities. The 2 1/2-day event provides for the presentation of papers and related panel discussions in five sessions. The symposium will close at noon on the third day to accommodate travel requirements of the attendees.
 - b. The theme of this year's event is SAFETY THRU EFFECTIVE MAINTENANCE which will emphasize new maintenance techniques and procedures. This will include maintenance concepts and plans for airframes, systems, powerplants, accessories, devices, avionics and electronics, and associated processes and systems.
 - c. Agenda. A cross section of the agenda reflects that technical aviation maintenance developments will be presented by manufacturers such as Douglas, Lockheed, Beech, and General Electric. Participating air carriers include American, United, Eastern and Air Canada. A panel concerning executive aircraft maintenance as well as FAA and NTSB papers are on the program. Persons who plan to attend may request a copy of the complete agenda after 15 October 1971 (see last paragraph for address).
