ADVISORY CIRCULAR

DEPARTMENT OF TRANSPORTATION FEDERAL AVIATION ADMINISTRATION

SUBJECT: ANNOUNCEMENT OF AVAILABILITY OF SUMMARY OF AIRWORTHINESS DIRECTIVES

1. PURPOSE. This circular announces the availability of a new Summary of Airworthiness Directives, dated January 1, 1976, and provides information as to the procedure for obtaining these documents.
2. CANCELLATION. Advisory Circular 39-6D, dated February 11, 1974, is cancelled.
3. DISCUSSION.
 - a. The Summary of Airworthiness Directives (AD's) containing all AD's issued prior to January 1, 1976, will become available on or about May 1, 1976. The Federal Aviation Administration's Aeronautical Center continues to be the sole source for this material. Do not submit orders to the U. S. Government Printing Office.
 - b. The price for Volume I (small aircraft) is \$14.00 (foreign mailing except Canada & Mexico \$3.50 additional). The price for Volume II (large aircraft) is \$13.00 (foreign mailing except Canada & Mexico \$3.25 additional). Payment by foreign purchasers should be by International Money Order payable in U. S. dollars.

NOTE: All remittances must be made payable to the Federal Aviation Administration.

- c. Full payment must be received in advance or with the order. Government entities, corporations, and any other public or private organizations are advised purchase orders submitted without payment will not be processed.

- d. Persons desiring to purchase either or both of these documents must submit a request (with payment) to:

Each purchaser (or his designated recipient) will receive free biweekly supplemental service for the duration of the publication cycle. Biweekly supplemental service is not otherwise available.

- e. Persons now receiving biweekly supplemental service because they purchased a previous issue are advised the publication cycle for their supplemental service will terminate on or about May 1, 1976.
- f. All persons wishing to assure prompt or uninterrupted supplemental service are encouraged to submit their order for purchasing the new 1976 summary by April 1, 1976.
- g. Summaries will be forwarded by regular mail. Biweekly supplemental service will be forwarded by first class mail to domestic purchasers and by air mail to foreign purchasers.
