## ANNOUNCEMENT OF AVAILABILITY

---

**Subject: SUMMARY OF AIRWORTHINESS DIRECTIVES**

1. **PURPOSE.** This circular announces the availability of a new Summary of Airworthiness Directives, dated January 1, 1980, and provides information for ordering these publications.
2. **CANCELLATION.** Advisory Circular 39-6F, dated March 6, 1978, is canceled.
3. **BACKGROUND.**

a. The 1980 Summary of Airworthiness Directives contains all current Airworthiness Directives (AD) issued through December 31, 1979. The AD's are separated into two volumes. Volume I - Small Aircraft contains AD's applicable to aircraft of 12,500 pounds or less maximum certificated takeoff weight. Volume II - Large Aircraft includes directives for aircraft of more than 12,500 pounds maximum certificated takeoff weight. AD's applicable to engines, propellers, and aeronautical products utilized on small aircraft are contained in Volume I. Similarly, those AD's applicable to engines, propellers, and aeronautical products utilized on large aircraft are contained in Volume II. The Federal Aviation Administration's Mike Monroney Aeronautical Center continues to be the sole source for the summaries. Do not submit orders for other FAA publications to the Aeronautical Center.

b. The AD summaries are updated and reprinted on a 2-year cycle. Persons who purchase a summary are provided biweekly supplements for a 2-year period which begins with the date of publication (January of even-numbered years) not the date of purchase. When ordering, please allow 6 full weeks between receipt of the first biweekly issue and arrival of the summary volume.

c. Persons now receiving biweekly supplemental service will continue to receive the service through April 1980 without additional cost.

d. All persons wishing to assure prompt or uninterrupted supplemental service are encouraged to submit their order for purchasing the new 1980 summary by April 1, 1980.

4. HOW TO ORDER. For convenience an order form is attached. If the form has been removed, submit your order as follows:

a. Be sure to identify the publication wanted by volume number and title.



b. Send a check or money order, payable to the Federal Aviation Administration, with your order in the amount indicated. Full payment must be received with the order. Government entities, corporations, and any other public or private organizations are advised purchase orders submitted without payment will not be processed. No c.o.d. orders are accepted.

Be sure to provide the name and address of the person who will receive the AD summary and biweekly supplements. Each purchaser (or designated recipient) will receive free biweekly supplemental service for the duration of the publication cycle. Biweekly supplemental service is not otherwise available. Summaries will be forwarded by regular mail. Biweekly supplemental service will be forwarded by first class mail to domestic purchasers and by priority mail to foreign purchasers. Initial distribution will be made on or about May 1, 1980.
