SUBJECT: AC 43.13-1A ACCEPTABLE METHODS, TECHNIQUES, AND PRACTICES -
AIRCRAFT INSPECTION AND REPAIR

1. **PURPOSE.** This advisory circular announces the availability to the public of Advisory Circular 43.13-1A, Acceptable Methods, Techniques, and Practices - Aircraft Inspection and Repair.
2. **DESCRIPTION.** AC 43.13-1A contains methods, techniques, and practices acceptable to the Administrator for inspection and repair of civil aircraft. AC 43.13-1 is cancelled. AC 43.13-1A contains minor updating of the material in AC 43.13-1, and it will not be a subscription item. Few future changes are planned for the new AC. When changes are made, they will be announced and made available for purchase in the same manner as described below for the basic AC.
3. **OBTAINING COPIES.** In addition to the mail order service provided by the Office of the Superintendent of Documents, U.S. Government Printing Office, Division of Public Documents, Washington, D.C. 20402, there are also 14 Government retail bookstores where copies of AC 43.13-1A may be ordered and/or purchased across the counter. Locations of the Government Printing Office bookstores are outlined in Appendix 1.
