1. PURPOSE. Announces the availability of the new series written test question books for use in the airman certification program.

2. BACKGROUND. The written test question books which have been in use since March 1, 1984, will expire September 1, 1986. On March 1, 1986, the Federal Aviation Administration made available a new series of question books to replace the obsolete books. Question selection sheets to be used with the new books will also be distributed to the written test examiners by the designating district offices.

3. GENERAL. Written test examiners are to order their supply of the new written test question books immediately. Examiners will be receiving the new question selection sheets and will be instructed to discontinue use of the old tests on September 1, 1986. The new books are available to the aviation public for study purposes. Applicants are encouraged to study and prepare for the new tests which are more representative of the current aviation environment than the tests which are 2 years older.

4. HOW TO ORDER. Effective immediately, orders will be accepted for the written test books by:
