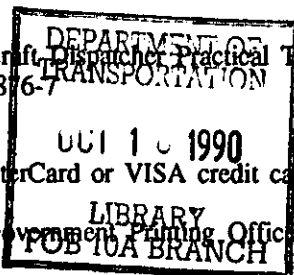

PRACTICAL TEST STANDARDS

- 1. PURPOSE.** Announces the availability of FAA-S-8081-10, Aircraft Dispatcher Practical Test Standards, from the Superintendent of Documents.
- 2. BACKGROUND.** In 1984, a revised system for conducting practical tests for pilot certification was established. In keeping with this concept, a practical test standard has been developed for the certification of aircraft dispatchers.
- 3. GENERAL.** The Aircraft Dispatcher Practical Test Standards has been published by the Federal Aviation Administration (FAA) to establish the standards for the aircraft dispatcher certification practical test. These standards are to be used by FAA inspectors and designated examiners when conducting the testing of an applicant for aircraft dispatcher certification. Instructors and applicants will find these standards helpful in practical test preparation.
