PURPOSE. Announces the availability of FAA-S-8081-6A, Flight Instructor Practical Test Standards for Airplane (Single-engine and Multiengine): FAA-T-8080-17, Airline Transport Pilot and Aircraft Dispatcher Written Test Book: FAA-T-8080-18, Flight and Ground Instructor Written Test Book; and FAA-T-8080-19, Flight Engineer Written Test Book, from the Superintendent of Documents.

BACKGROUND. In 1984, a revised system for conducting written tests for pilot certification was established. In keeping with this concept, a practical test standard has been developed for the certification of airplane (single-engine and multiengine) flight instructors.

The written test books are replaced on a bi-annual basis. FAA-T-8080-3C, Fundamentals of Instructing, Flight Instructor, Ground Instructor - Basic and Advanced Question Book, is replaced by FAA-T-8080-18; FAA-T-8080-5C, Airline Transport Pilot, Aircraft Dispatcher, and Flight Navigator Question Book, is replaced by FAA-T-8080-17; and FAA-T-8080-8C, Flight Engineer Question Book, is replaced by FAA-T-8080-19.

GENERAL. The Flight Instructor Practical Test Standards for Airplane (Single-Engine and Multiengine) has been published by the Federal Aviation Administration (FAA) to establish the standards for the flight instructor airplane (single-engine and multiengine) certification practical test. These standards are to be used by FAA inspectors and designated examiners when conducting the testing of an applicant for airplane flight instructor certification. Instructors and applicants will find these standards helpful in practical test preparation.

The FAA Written test books are to be purchased by the Designated Written Examiners for use when administering tests. Official copies must be obtained from the Superintendent of Documents at the address listed in paragraph 4. Applicants may find these books helpful when preparing for the airmen certification written tests.
