

FHWA Federal-Aid Division State Planning and Research Subpart B (SPR-B) Program

State planning and research (SPR) funds establish a comprehensive framework for making transportation investment decisions and carrying out transportation research activities throughout a State. The SPR-B program helps States develop innovative, research-driven solutions to increasingly complex transportation challenges. The basic principles governing this program are outlined in 23 U.S. Code (USC) Chapter 505 (b) and 23 Code of Federal Regulation (CFR) 420, which define how partners can use SPR-B funds for research, development, and technology transfer.

WHERE SHOULD I START?

A helpful place to start is the American Association of State Highway and Transportation Officials Research Advisory Committee (RAC) 101 introduction. The introduction provides a great overview of the RAC community. Another helpful resource is the SPR-B program checklist, which outlines all the high-level action items that need to be overseen and the respective actions and timeline for both the State department of transportation (DOT) and Federal Highway Administration (FHWA) Division office. A 4-hour online National Highway Institute (NHI) <u>Research 101 course</u> is also available and provides an overview of the administration of the SPR-B program.

WHERE CAN I GET ANSWERS TO MY QUESTIONS?

Each State's local FHWA division research coordinator is a great resource for SPR-related questions. FHWA's Office of Corporate Research, Technology and Innovation Management also helps to support the program, but final determinations remain with the FHWA division office.

SPR-B GUIDANCE

State Planning and Research Funds Overhead/Indirect Cost Rate Guidance:

This FHWA memorandum, issued in July 2017, provides guidance to State DOTs on how the overhead/indirect cost rate should be calculated by universities when conducting research for DOTs using FHWA SPR funds.

FHWA, State DOT, and MPO Rights to Copyrighted and Patented Items Developed with FHWA Planning and Research Funds:

This guidance provides information on copyrighted publications and patented inventions or discoveries resulting from activities performed with FHWA planning and research funds.

State Planning and Research Program Research, Development, and Technology Transfer Program Management Guidance for Implementing 23 CFR Part 420, Subpart B:

This guidance, published in October 2018, is intended to assist FHWA and State DOT staff in implementing the 23 CFR Part 420, Subpart B Research, Development, and Technology Transfer Program Management regulations.

This FHWA guidance, first published in January 2004 and subsequently updated in April 2017, clarifies the eligibility of FHWA SPR and metropolitan planning funds for travel and training.
