1. **PURPOSE.** Announces the availability of the new Private Pilot Practical Test Standards from the Superintendent of Documents on a subscription basis for an indeterminate period.
2. **BACKGROUND.** Advisory Circular 61-93, Replacing the Flight Test Guides with Practical Test Standards, dated 3-27-84, outlines the revised system for conducting practical testing to established standards for pilot certification. Flight test guides in the advisory circular system are being replaced by a new system of practical test standards publications.
3. **GENERAL.** The Private Pilot Practical Test Standards book has been published by the FAA to establish the standards for the private pilot certification practical test for all aircraft categories and classes. These standards are to be used by FAA inspectors and designated pilot examiners when conducting the testing of an applicant's performance of those procedures and maneuvers required for private pilot certification. Flight instructors and applicants will find these standards helpful in practical test preparation.
4. **HOW TO ORDER.** Effective immediately, orders will be accepted for FAA-S-8081-1, Private Pilot Practical Test Standards, which may be obtained from:
