**SUBJECT :** LOCATION IDENTIFIERS, AT P 7350.1A

1. PURPOSE. This circular announces the availability to the public of an internal Federal Aviation Agency handbook on the indicated subject.
2. DESCRIPTION OF THE PUBLICATION. This internal FAA handbook incorporates all authorized three-letter location identifier assignments worldwide, the Canadian Government location identifier assignments, and special use assignments for the United States and its jurisdictions.

Because each edition is complete in itself, the subscription can be initiated at any time. When the subscription runs out, a renewal notice and order blank will be mailed prior to the next edition. A renewal subscription will not include a new set of dividers. This is a revised method of issuing the Location Identifiers Handbook.
