





NTL Data Services to Implement Data Curation Network CURATED Workflow


CURATED Workflow is a standardized set of steps and checklists to ensure all datasets receive consistent and documented treatment.

- C:** Check files/code and read documentation;
- U:** Understand the data (or try to);
- R:** Request missing information or changes;
- A:** Augment metadata for findability;
- T:** Transform file formats for reuse;
- E:** Evaluate for FAIRness ;
- D:** Document all curation activities throughout the process

NTL Joins Federal ORCID Consortium



On May 1, 2023, NTL joined the Federal ORCID Consortium, lead by Department of Energy's Office of Scientific and Technical Information (OSTI)

- ORCID = Open Researcher and Contributor Identifier
 - Global, unique, disambiguating identifier for researchers, which links to research outputs.

- Required by DOT Public Access Plan and National Security Presidential Memorandum 33 <https://www.whitehouse.gov/wp-content/uploads/2022/01/010422-NSPM-33-Implementation-Guidance.pdf>
- With membership we get lower cost programmatic integration with NTL cataloging and repository systems.
- Integration will allow us to “push” information to author ORCID records, as well as “pull” disambiguating information such as other forms of name and employer

DOT Public Access Plan update triggered by OSTP 2022-08-25 Memo



Ensuring Free, Immediate, and Equitable Access to Federally Funded Research Alondra Nelson, White House OSTP August 25, 2022

Extends public access guidance defined in 2013 Public Access memo

1. All federal agencies with any amount of R&D should make **research results** (research project information, publications, datasets, etc.) **discoverable and useable to the general public**, to the greatest extent possible, **freely and without embargo or delay**.
2. Use **COVID-19 response times and lessons** to promote more rapid research transparency, while also **improving scientific integrity**.
3. Greater **federal coordination** between **OSTP** and **departments and agencies**.

Deadlines

1. **2024-12-31:** "...federal agencies should **submit to OSTP and OMB** a second update to their public access plans specifying approaches taken to implement the provisions in this [memo] **Section 4** [Ensuring Scientific and Research Integrity in Agency Public Access Policies].” (page 6)
2. **2025-12-31:** “[F]ederal agencies, to the extent consistent with applicable law: 1. **Update their public access policies as soon as possible**, and no later than December 31st, 2025, to make **publications** and their **supporting data** resulting from federally funded research **publicly accessible without an embargo** on their free and public release...” (page 1)
3. **2026-12-31:** “Agencies should **complete and publish full policy development** for plans implementing these **[Section 4] provisions** by December 31st, 2026, with an **effective date no later than one year after** the publication of the agency plan.” (page 6)
