I'M VERY PROUD OF THESE ACCOMPLISHMENTS, AND I CAN TELL YOU THELMA PLAYED AN IMPRESSIVE PART IN THIS ACHIEVEMENT. HER COMMITMENT TO DISADVANTAGED BUSINESS ENTERPRISE IS UNSWERVING.
