- * THANK YOU, JON, FOR SERVING AS MY VICE-CHAIRPERSON FOR THIS YEAR'S SAVINGS BOND DRIVE.
- * AND A SPECIAL THANKS TO YOU, ADMINISTRATION VICE CHAIRPERSONS AND COORDINATORS. I APPRECIATE YOUR WILLINGNESS AND THE TIME AND EFFORT YOU CONTRIBUTE TO ASSIST IN THE DEPARTMENT'S SAVINGS BOND CAMPAIGN. AS A MATTER OF FACT, RSPA HAD 67 PERCENT PARTICIPATION. IF EACH ADMINISTRATION WOULD DO AS WELL AS THEY DID LAST YEAR AND INCREASE THEIR PARTICIPATION BY JUST A FEW PERCENTAGE POINTS WE COULD EASILY MEET OUR DEPARTMENT-WIDE GOAL. AND RSPA IS LEADING THE WAY AGAIN THIS YEAR, WITH 53 PERCENT PARTICIPATION AS WE BEGIN THIS NEW CAMPAIGN.
