- * HAVE SENT CONGRESS LEGISLATION TO COMPLETE DEREGULATION OF THE TRUCKING INDUSTRY.
- * ABSURDITY OF ICC'S TARIFF FILING REQUIREMENTS: TARIFFS FILED FOR JIFFY POP -- ORVILLE REDENBACHER IS EXEMPT; FROZEN DINNERS ARE NOT EXEMPT, BUT FROZEN CHICKEN AND SEAFOOD DINNERS EXEMPT; RAILROAD TIES SAWED CROSSWISE ARE EXEMPT, RAILROAD TIES SAWED LENGTHWISE ARE NOT.

- * OUR BILL WILL ELIMINATE REMAINING ICC REGULATIONS OF TRUCKING RATES AND ENTRY AND ALL ANTITRUST IMMUNITY FOR COLLECTIVE RATEMAKING, CARRIERS WOULD BE ABLE TO CHOOSE ROUTES, RATES AND COMMODITIES THEY WISH TO CARRY.
- * SAFETY WILL NOT BE COMPROMISED.
- * REMAINING REGULATION UNNEEDED AND UNDESIRABLE -- PRODUCTIVITY IMPROVED.

OHIO'S BILL PASSED FULL SENATE AND ONE HOUSE COMMITTEE THIS YEAR, BUT LEGISLATURE "DROPPED" EVERYTHING TO FOCUS ON HOME STATE SAVINGS AND LOAN CRISIS AND WENT INTO RECESS BEFORE FURTHER ACTION OCCURRED. HOUSE RECONVENES NOV. 12. GOVERNOR CELESTE (D) SUPPORTS LAW. OVER 600 OHIO COMPANIES PARTICIPATED IN SAFETY BELT COALITION TO PROMOTE SAFETY BELT USE.)

(NOTE: AGE 21: "TOUCHY POLITICAL SUBJECT" IN OHIO, WAS 1984 BALLOT ISSUE THAT WAS EASILY DEFEATED. LAW IS STILL 19 FOR BEER AND WINE, 21 FOR OTHER ALCOHOL.

ATTACHMENT A

MICHIGAN CONRAIL NOTE

THE TWO KEY ELEMENTS ARE IMPACT OF SALE ON GRAND TRUNK WESTERN AND CONGRESSMAN DINGELL'S POSITION. GTW ACTIVELY OPPOSING SALE TO NS IN EFFORT TO GAIN ACCESS TO CHICAGO AND ST. LOUIS. DINGELL REQUESTED INDEPENDENT ANALYSIS OF THE SALE FROM USRA, HAS NOT TAKEN POSITION, HAS CORRESPONDED WITH DOT RAISING COMPETITIVE ISSUES, QUESTIONS EFFECTIVENESS OF JUSTICE REVIEW, VIABILITY OF DIVESTITURES, AND IMPACT ON REGIONAL CARRIERS. CSX HAS LARGE PRESENCE IN THE STATE, LOBBIED HARD AGAINST THE SALE. JUSTICE IDENTIFIED COUNTIES OF WAYNE (DETROIT) AND WASHTENAW (ANN ARBOR) AS PROBLEM COUNTIES WHICH COULD BE ADDRESSED THROUGH ROUTINGS VIA TOLEDO.

MICHIGAN DOT AND GOVERNOR BLANCHARD HAVE TAKEN NO OFFICIAL POSITION; HAVE FOLLOWED SALE CLOSELY; MET WITH ALL MAJOR PARTIES.

SENATOR RIEGLE OPPOSES, VOTED AGAINST REPORTING THE NS PLAN FROM COMMERCE COMMITTEE LAST APRIL; IS CLOSE TO RAIL LABOR WHO HAVE REACHED AGREEMENT WITH MORGAN STANLEY ON ITS INTERESTS. TO DATE, NS HAS BEEN UNABLE TO NEGOTIATE AGREEMENTS WITH LABOR. NEITHER SENATOR LEVIN NOR ANY OF THE HOUSE MEMBERS HAVE TAKEN A PUBLIC POSITION ON THE SALE.

DETROIT NEWS AND DETROIT FREE PRESS HAVE BEEN NEGATIVE; CONCERNED WITH SALE AT LARGE AND NOT AS A PAROCHIAL CONCERN; FREE PRESS NEGATIVE EDITORIAL REVERSES THE PAPER'S EARLY ENDORSEMENT OF THE SALE.

ATTACHMENT B OHIO CONRAIL NOTE

WHILE THERE ARE GREAT BENEFITS TO BE GAINED FROM MERGER, NS WOULD CONSOLIDATE MORE FACILITIES AND MORE JOBS WOULD BE AFFECTED THAN ANY OTHER STATE. COLLINWOOD SHOPS (CLEVELAND) ARE PROPOSED TO BE CLOSED (MAJOR REPAIR FACILITY WHICH CONRAIL HAD BEEN DOWNGRADING UNTIL THEY REVERSED PLAN AND PROMISED TO SPEND \$900,000 TO REJUVENATE IN RETURN FOR STATE'S SUPPORTING AN INDEPENDENT CONRAIL). ALTHOUGH NS ANTICIPATES 1,200 JOBS AFFECTED BY MERGER STATE BELIEVES 800 OF THOSE JOBS ARE IN OHIO. OVERRIDING ISSUE WITH GOVERNOR AND ATTORNEY GENERAL CELEBREZZE IS COMPETITION AND IMPACT OF THE DIVESTITURES ON COMPETITIVE RAIL OPTIONS FOR OHIO SHIPPERS; PERCEIVE GUILFORD ACQUISITIONS WILL NOT PROVIDE EFFECTIVE COMPETITIVE

ALTERNATIVES FOR SHIPPERS; IN FACT, INTRODUCTION OF GUILFORD INTO OHIO GIVES SHIPPERS NEW OPTION INTO THE NORTHEAST. ALTHOUGH PITTSBURGH AND LAKE ERIE RAILROAD HAS DIM FUTURE UNDER A STATUS QUO SITUATIONS, OHIO DOT AND OTHER POLITICIANS HAVE NOT LINKED DIVESTITURE PROGRAM TO SOLVING P&LE'S PROBLEMS. ATTORNEY GENERAL CELEBREZZE TESTIFIED BEFORE HOUSE JUDICIARY COMMITTEE AND RAISED NUMEROUS COMPETITIVE CONCERNS WITH SALE.

GOVERNOR CELESTE ANNOUNCED SUPPORT FOR MORGAN STANLEY OPPOSITION TO NS; WROTE MEMBERS OF CONGRESSIONAL DELEGATION, ATTACHED A PARSONS, BRINKERHOFF STUDY COMMISSIONED BY OHIO DOT; CLAIMS RAISES CONCERNS ABOUT COMPETITIVE IMPACT OF SALE. SHORTLY AFTER GOVERNOR ANNOUNCED SUPPORT, MINORITY LEADER OF OHIO SENATE

** WROTE LETTER TO DELEGATION ENCOURAGING NS SUPPORT. A NUMBER OF TOWNS HAVE PASSED RESOLUTIONS ENDORSING THE SALE.

SENATOR METZENBAUM STRONGLY OPPOSES BOTH PLANS AND IS LAYING GROUNDWORK FOR THIRD OPTION -- NOT SELLING AT ALL. SENATOR GLENN HAS NO POSITION. IN HOUSE, DENNIS ECKART (D) IS THE KEY SPONSOR OF MORGAN STANLEY BILL. OTHER MEMBERS, FEIGAN, DEWINE, APPLEGATE, HAVE RAISED CONCERNS, PARTICULARLY WITH JUSTICE'S REVIEW OF COMPETITIVE IMPLICATIONS.

NEGATIVE EDITORIALS INCLUDE AKRON, CINCINNATI, CLEVELAND, DAYTON, LORAIN, TOLEDO, WARREN, AND YOUNGSTOWN. POSITIVE EDITORIALS HAVE BEEN WRITTEN IN ULRICHSVILLE, MARION, CANTON AND A FEW OTHER SMALL TOWN NEWSPAPERS.
