- * MOST OF THE TIME YOU ARE ABLE TO HANDLE AND RESOLVE ISSUES IN THE FIELD BEFORE THEY GROW INTO FULL FLEDGED LAWSUITS.
- * MANY HIGHWAY PROJECTS REPRESENT A TREMENDOUS AMOUNT OF MONEY AND THEREFORE A TREMENDOUS AMOUNT OF RESPONSIBILITY FOR EACH AND EVERY ONE OF YOU.
- * ENVIRONMENTAL ISSUES ARE ESPECIALLY COMPLEX AND CONTROVERSIAL,
 BUT THANKS TO YOUR EFFORTS, PROJECTS THAT ARE ACTUALLY LITIGATED

REPRESENT ONLY A SMALL PORTION OF ALL PROJECTS UNDERTAKEN BY FHWA EACH YEAR.

- * IN YOUR HANDLING OF MBE FRONTS AND FRAUDS, AND MONEY RECOVERIES, I APPRECIATE YOUR GETTING OUT THE MESSAGE FAR AND WIDE THAT WE WON'T DEAL WITH CONTRACTORS WHO TRY TO SLIP THROUGH LOOPHOLES AND TAKE ADVANTAGE OF OUR LAWS.
- * WE SIMPLY WILL NOT DO BUSINESS WITH WRONGDOERS AND WE WILL RECOVER OUR MONIES WHEN AND WHERE WE CAN FROM THOSE WHO WOULD UNLAWFULLY ENRICH THEMSELVES FROM OUR PROGRAMS.
- * I WANT YOU TO KNOW THAT THERE IS NO RESPONSIBILITY THAT YOU AS REGIONAL AND AS ASSISTANT REGIONAL COUNSELS HAVE THAT IS MORE IMPORTANT THAN YOUR RESPONSIBILITY IN ENFORCING THE FEDERAL MOTOR CARRIER SAFETY REGULATIONS.

- * THE MOTOR CARRIER SAFETY ACT OF 1984 HAS GIVEN YOU SOME OF THE TOOLS YOU HAVE LONG NEEDED TO MORE EFFECTIVELY PROMOTE TRUCK SAFETY.
- * YOUR EXPERIENCE AND THAT OF YOUR COUNTERPARTS IN OTHER MODES IS INVALUABLE TO THE OVERALL DEPARTMENTAL AGENDA.

 - B) 208 (15 YEARS); AGE 21; 16 STATES PASSED -- D.C. (IF PASSES CONGRESS);
 - C) HIGH MOUNTED LIGHT;
 - D) ROADS AND BRIDGES -- HIGHWAY REAUTHORIZATION (AT OMB); EXTEND HIGHWAY TRUST FUND; LONG-RANGE VIEWS;
