THANK YOU, DAN (CONGRESSMAN SCHAEFER), FOR THOSE KIND WORDS OF INTRODUCTION. LET ME SAY AT THE OUTSET THAT DAN SCHAEFER IS ONE OF THE MOST EFFECTIVE MEMBERS OF CONGRESS. CHAMBER AND PUBLIC OFFICIALS -- LEADERS OF A VERY AGGRESSIVE ECONOMIC DEVELOPMENT PROGRAM. I KNOW YOUR AIRPORT IS A HIGH PRIORITY IN YOUR GROWTH PLANS. AND I'M DELIGHTED THAT YOU PLACE TRANSPORTATION AS THE CENTERPIECE OF YOUR ECONOMIC DEVELOPMENT. YOUR VALUES ARE WELL PLACED.

LET ME SPEND JUST A MOMENT GIVING YOU A BRIEF OVERVIEW OF NATIONAL TRANSPORTATION PRIORITIES.

BUSINESS AND INDUSTRY LEADERS OF AURORA DO NOT NEED TO BE CONVINCED. THE TRADITION OF THIS CITY AS A TRANSPORTATION HUB IS WELL-ESTABLISHED, AND MUCH OF YOUR ECONOMY HAS BEEN BUILT ON THE QUALITY OF YOUR TRANSPORTATION FACILITIES. THERE IS NO DOUBT IN MY MIND THAT AURORA WILL MORE THAN MEET THE CHALLENGES. I LOOK FORWARD TO MAKING THE JOURNEY WITH YOU.
