- -- GLAD TO BE INVITED TO VISIT WITH YOU -- WE HAVE A LOT IN COMMON -- MOST OBVIOUSLY THIS EVENING OUR SUPPORT FOR BOB GRIFFIN.
- -- HAVE KNOWN HIM FOR YEARS, AND GOT TO WORK CLOSELY WITH BOB DURING THE 1976 CAMPAIGN, WHEN MY HUSBAND WAS PRIVILEGED TO BE GERALD FORD'S RUNNING MATE. BOB AND I HAVE THE DEEPEST RESPECT AND ADMIRATION FOR BOB GRIFFIN.
- -- A MAN OF INTEGRITY AND PRINCIPLE OF THE HIGHEST URDER.
