Secretary of Transportation William T. Coleman Jr. today officiated at swearing in ceremonies for Charles F. Bingman as Deputy Administrator of the Department's Urban Mass Transportation Administration (UMTA).

Mr. Bingman brings to UMTA more than 20 years of experience in the Federal government in organizational, policy and program management positions. As Deputy, he will provide administrative direction and leadership to clarify UMTA's decision-making process, improve and speed up its grant making and procurement practices, and build a more effective field structure to serve UMTA's future needs.

Mr. Bingman previously held several positions with the U.S. Office of Management and Budget (OMB) between 1971 and 1976. Since 1973, he was Deputy Associate Director of Organization and Special Studies, holding responsibilities for government-wide organizational matters. During this period he played a key role in the creation of a number of new Federal agencies, including the Federal Energy Administration, the Energy Research and Development Administration, and the Consumer Product Safety Commission.

Prior to his OMB service, Mr. Bingman held several management positions with the National Aeronautics and Space Administration. He was Special Assistant to the Associate Administrator for Organization and Management, Deputy Director of the Organization and Management Planning Division, and Director of Manned Space Flight Management Programs.

From 1962-1966, he served in various positions at the Lyndon B. Johnson Space Center in Houston. He was Manager of Center Support Planning and Control, Chief of the Management Services Division and Chief of the Management Analysis Division.

He also served as a management/manpower analyst at NASA and the Atomic Energy Commission.

Mr. Bingman holds a Bachelor of Business Administration degree from the University of Wisconsin, 1952; and an M.B.A. from the University of Wisconsin, where he was graduated magna cum laude. He was a member of the first class of the Federal Executive Institute in Charlottesville, Virginia in 1968.

He is a fellow of the National Academy of Public Administration, a member of the American Society of Public Administration and has served as President of the Houston Chapter and Vice President of the Washington, D.C. Chapter of the ASPA.
